

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Leaya Jalove DOCKET NO.: 20-27748.001-R-1 PARCEL NO.: 18-20-107-096-0000

The parties of record before the Property Tax Appeal Board are Leaya Jalove, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$2,943 **IMPR.:** \$17,338 **TOTAL:** \$20,281

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of frame exterior construction with 1,598 square feet of living area. The dwelling is approximately 45 years old. Features of the home include a crawl space foundation, central air conditioning, one fireplace and a 2-car garage. The property has an approximately 3,568 square foot site and is located in Indian Head Park, Lyons Township, Cook County. The subject is classified as a class 2-95 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables located in the same assessment neighborhood code as the subject property. The comparables are improved with class 2-95 dwellings of frame exterior construction with either 1761 or 1961 square feet of living area. The homes range in age from 42 to 47 years old. Each

comparable has a crawl space or concrete slab foundation, central air conditioning, one fireplace and a 2-car garage. The comparables have improvement assessments ranging from \$18,844 to \$21,971 or from \$10.70 to \$11.20 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$17,338 or \$10.85 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" for a parcel which is not the subject property. The appellant submitted a copy of the Cook County Board of Review final decision disclosing the total assessment for the subject of \$21,771. The appellant's appeal petition disclosed the subject has an improvement assessment of \$18,828 or \$11.78 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables located in a different assessment neighborhood code than the subject property. The comparables are improved with three-story class 2-95 dwellings of masonry exterior construction each with 2,565 square feet of living area and 10 years old. Each comparable has a concrete slab foundation, central air conditioning and a 2-car garage. The comparables have improvement assessments ranging from \$44,046 to \$56,224 or from \$17.17 to \$21.92 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted eight equity comparables for the Board's consideration. The Board gives less weight to appellant comparables #3 and #4 along with each of the board of review's comparables which are less similar to the subject in dwelling size and/or age when compared to other properties in the record. Furthermore, each of the board of review's comparables differ from the subject in location and design. The Board finds the best evidence of assessment equity to be appellant comparables #1 and #2 which are more similar to the subject in location, age, design, dwelling size and most features. These comparables each have an improvement assessment of \$18,844 or \$10.70 per square foot of living area. The subject's improvement assessment of \$18,828 or \$11.78 per square foot of living area falls just below the two best comparables in this record on an overall improvement assessment basis and above the two best comparables on a per square foot basis. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant demonstrated with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment, commensurate with the request, is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

## **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
