

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Anthony Smith, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,161 **IMPR.:** \$41,955 **TOTAL:** \$47,116

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame exterior construction with 2,797 square feet of living area. The dwelling is approximately 12 years old. Features of the home include a crawl space foundation, central air conditioning and a 2-car garage. The property has an approximately 14,747 square foot site and is located in Countryside, Lyons Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on three equity comparables located in the same assessment neighborhood code as the subject property. The comparables are improved with class 2-78 dwellings of frame or frame and masonry exterior construction ranging in size from 3,295 to 3,584 square feet of living area. The homes range in

age from 22 to 35 years old. Each comparable has an unfinished basement, central air conditioning, one fireplace and a 3-car or a 3.5-car garage. The comparables have improvement assessments ranging from \$43,263 to \$49,989 or from \$12.07 to \$14.78 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$38,571 or \$13.79 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$47,116. The subject property has an improvement assessment of \$41,955 or \$15.00 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparables located in the same assessment neighborhood code as the subject property. The comparables are improved with two-story class 2-78 dwellings of frame, masonry, stucco or frame and masonry exterior construction ranging in size from 2,386 to 3,556 square feet of living area. The homes range in age from 22 to 34 years old. Each comparable has an unfinished basement, one fireplace and from a 1.5-car to a 4-car garage. Three dwellings have central air conditioning. The comparables have improvement assessments ranging from \$45,577 to \$56,909 or from \$16.00 to \$20.17 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted seven equity comparables for the Board's consideration. The Board finds both parties' comparables are older in age being 22 to 35 years old while the subject is 12 years old and have a basement foundation in contrast to the subject's crawl space foundation. Nevertheless, the Board gives less weight to appellant comparables #1 and #2 along with board of review comparable #2 all of which are more than 20% larger in dwelling size when compared to the subject.

The Board finds the best evidence of assessment equity to be appellant comparable #3 and board of review comparables #1, #3 and #4 which are more similar to the subject in location and dwelling size but present varying degrees of similarity to the subject in age, foundation type and other features. These best comparables have improvement assessments ranging from \$45,577 to \$50,515 or from \$14.78 to \$20.17 per square foot of living area. The subject's improvement assessment of \$41,955 or \$15.00 per square foot of living area falls below the range established by the best comparables in this record on an overall improvement assessment basis and within the range on a per square foot basis. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and

convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
