

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Jamal Shaban, the appellant, by Amy C. Floyd, Attorney at Law in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$3,038 **IMPR.:** \$17,462 **TOTAL:** \$20,500

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a multi-level dwelling of frame exterior construction with 1,150 square feet of living area. The dwelling is approximately 48 years old. Features of the home include a basement with finished area, central air conditioning, one fireplace, and a 2-car garage. The property has a 7,150 square foot site and is located in Tinley Park, Orland Township, Cook County. The subject is classified as a class 2-34 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located in the same neighborhood code as the subject property. The comparables are improved with multi-level dwellings of frame and masonry exterior construction ranging in size from 1,360 to 1,626 square feet of living area. The comparables range in age from 48 to 58

years old. Each comparable has a basement with finished area and a garage.¹ Three comparables each have central air conditioning. The comparables have improvement assessments ranging from \$14,103 to \$16,852 or from \$10.24 to \$10.63 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced to \$11,926 or \$10.37 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$20,500. The subject property has an improvement assessment of \$17,462 or \$15.18 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on three equity comparables located in the same neighborhood code and the same block as the subject property. The comparables are improved with multi-level dwellings of frame exterior construction with either 938 or 1,080 square feet of living area. The comparables are either 44 or 48 years old. Each comparable has a basement with finished area and a 2-car garage. Two comparables each have central air conditioning. Two comparables each have one fireplace. The comparables have improvement assessments ranging from \$14,811 to \$18,919 or from \$15.79 to \$17.52 per square foot of living area. Based on this evidence, the board of review requested the assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted seven suggested comparables for the Board's consideration. The Board finds the best evidence of assessment equity to be board of review comparables #1 and #2 which are overall more similar to the subject in location, design, age, dwelling size, and most features. These two comparables had improvement assessments of \$17,070 and \$18,919 or \$15.81 and \$17.52 per square foot of living area, respectively. The subject's improvement assessment of \$17,462 or \$15.18 per square foot of living area is bracketed by the two best comparables in this record on an overall improvement assessment basis but below them on a per square foot basis. The Board gives less weight to the appellant's comparables and board of review comparable #3 due to differences in dwelling size when compared to the subject. Based on this record and after considering adjustments to the two best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
