

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: BMR Properties LLC DOCKET NO.: 20-37312.001-R-1 PARCEL NO.: 30-17-102-001-0000

The parties of record before the Property Tax Appeal Board are BMR Properties LLC, the appellant, by Brian P. Liston, of the Law Offices of Liston & Tsantilis, P.C. in Chicago, and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$1,061 **IMPR.:** \$5,378 **TOTAL:** \$6,439

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one and one-half-story dwelling of frame exterior construction with 1,505 square feet of living area. The dwelling is 127 years old. Features of the home include a crawl foundation and central air conditioning. The property has a 3,033 square foot site and is located in Calumet City, Thornton Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on three equity comparables improved with one-story or one and one-half story, class 2-03 dwellings of frame or brick exterior construction that range in size from 1,497 to 1,796 square feet of living area. The homes are from 100 to 125 years old. Each comparable has a full basement with one having

finished area, while two of the comparables have central air conditioning and two properties have a detached, two-car garage. The comparables have the same assessment neighborhood code as the subject and are located from 0.30 to 0.70 of a mile from the subject property. The comparables have improvement assessments that range from \$2,285 to \$5,474 or \$3.00 and \$3.05 per square foot of living area. The appellant requested the subject's improvement assessment be reduced to \$4,560.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$6,439. The subject property has an improvement assessment of \$5,378 or \$3.57 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables improved with one-story or one and one-half story¹, class 2-03 dwellings of frame, brick or frame and brick exterior construction that range in size from 1,056 to 1,440 square feet of living area. The homes range in age from 65 to 97 years old. Each comparable has a full or partial basement with one having finished area, while three of the comparables have a garage and one has a fireplace. The comparables have the same assessment neighborhood as the subject and are located within one-fourth of a mile from the subject property. The comparables have improvement assessments that range from \$4,425 to \$7,011 or from \$3.92 to \$6.18 per square foot of living area.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains seven equity comparables submitted by the parties to support their respective positions. The Board gives less weight to the appellant's comparable #3 due to differences from the subject dwelling in terms of dwelling size. The Board gives less weight to the board of review's comparables #2, #3, and #4 due to differences from the subject dwelling with respect to size and/or age. The Board finds the remaining comparables are the best comparables in this record, although adjustments to these comparables to account for differences in some features and age, would be needed to make them more equivalent to the subject. These comparables are from 93 to 125 years old, range in size from 1,440 to 1,668 square feet of living area and have improvement assessments ranging from \$2,285 to \$6,315 or from \$3.00 to \$4.39 per square foot of living area. The subject's improvement assessment of \$5,378 or \$3.57 per square foot of living area falls within the range established by the best comparables in this record. Based on this evidence and after considering appropriate adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate

with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
