

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Mohd Shuibi, the appellant, by attorney Dimitrios Trivizas, of Dimitrios P. Trivizas, Ltd. in Skokie, and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$4,764 **IMPR.:** \$23,729 **TOTAL:** \$28,493

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame and brick exterior construction with 2,511 square feet of living area. The dwelling is 33 years old. Features of the home include a partial basement, central air conditioning, a fireplace and a two-car garage. The property has a 9,075 square foot site and is located in Tinley Park, Orland Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on three equity comparables improved with two-story, class 2-78 dwellings of frame and brick exterior construction that range in size from 2,907 to 3,039 square feet of living area. The homes are from 28 to 30 years old. Each comparable has a full or partial basement, one or two fireplaces,

and either a two, two and one-half, or three-car garage. One comparable has central air conditioning. The comparables have the same assessment neighborhood code as the subject and are located from 1.06 to 1.46 miles from the subject property. The comparables have improvement assessments that range from \$22,260 to \$24,616 or from \$7.66 to \$8.10 per square foot of living area. The appellant requested the subject's improvement assessment be reduced to \$19,904.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$28,493. The subject property has an improvement assessment of \$23,729 or \$9.45 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables improved with two-story, class 2-78 dwellings of frame and brick exterior construction that range in size from 2,385 to 2,539 square feet of living area. The homes are from 31 to 33 years old. Each comparable has a partial basement, central air conditioning, a fireplace, and a two-car garage. The comparables have the same assessment neighborhood code as the subject and are located either on the same block or within one-fourth of a mile from the subject property. The comparables have improvement assessments that range from \$24,588 to \$26,088 or from \$10.27 to \$10.89 per square foot of living area.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight equity comparables submitted by the parties to support their respective positions. The Board gives less weight to the appellant's comparables due to differences from the subject dwelling in terms of size, location and amenities. The appellant's comparables are from 14% to 17% larger than the subject dwelling and are located from 1.06 to 1.46 miles from the subject property. The Board finds the best evidence of assessment equity to be the board of review's comparables, which are the most similar to the subject dwelling in terms of size, age, location, and amenities. These comparables are from 31 to 33 years old, range in size from 2,385 to 2,539 square feet of living area and have improvement assessments that range from \$24,588 to \$26,088 or from \$10.27 to \$10.89 per square foot of living area. The subject's improvement assessment of \$23,729 or \$9.45 per square foot of living area falls below the range established by the best comparables in the record. Based on this evidence and after considering appropriate adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Docket No: 20-40150.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
