



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Marcin Wisniowski, the appellant(s), by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$10,353
IMPR.: \$17,835
TOTAL: \$28,188

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2020 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame construction with 3,513 square feet of living area. The dwelling was constructed in 2004. Features of the home include a full basement with a formal recreational room, central air conditioning, a fireplace, and a 3-car garage. The property has a 17,256 square foot site and is located in Hoffman Estates, Hanover Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation and assessment inequity as the basis of the appeal. In support of the appellant's overvaluation argument, four comparable sales were submitted. The comparable properties sold from December 2018 to March 2020 for prices from \$207,901 to \$287,000. The comparable properties ranged: in living square footage between 2,763 to 3,513; and in sale price per square foot between \$75.24 to \$88.51, including land.

The appellant also contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on nine equity comparables of frame construction. The comparables ranged: in age from 16 to 19 years old; in size from 2,930 to 3,513 square feet of living area; and in improvement assessment from \$10.02 to \$10.20 per square foot of living area. Based on this evidence, the appellant arrived at a requested assessment for the subject of \$27,732. The petition disclosed the subject is an owner-occupied residence.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$35,118. The subject's assessment reflects a market value of \$351,180 or \$99.97 per square foot of living area, including land.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables, two of which reflected sales data. The comparables ranged: in age from 17 to 21 years old; in size from 2,826 to 3,067 square feet of living area; and in improvement assessment from \$8.11 to \$8.93 per square foot of living area. The sales occurred from April 2018 to November 2018. The comparable properties both contained 2,826 square feet of living area and ranged: in price from \$378,000 to \$421,600 or 133.76 to \$149.19 per square foot, including land.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales, or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant *did meet* this burden of proof and a reduction in the subject's assessment *is* warranted.

The Board finds the best evidence of market value to be *appellant's comparable sales #2, #3, and #4*. These comparable sales were given greater weight due to their size relative to the subject. These comparable properties sold between December 2018 to March 2020 for prices ranging from \$70.31 to \$88.51 per square foot of living area, including land. The subject's assessment reflects a market value of \$99.97 per square foot of living area, including land, which is above the range established by the best comparable sales in this record. Based on this evidence the Board finds a reduction in the subject's assessment *is* justified. After this reduction, the Board finds the subject is equitably assessed.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
