

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Yumi Fujimoto

The parties of record before the Property Tax Appeal Board are Yumi Fujimoto, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$82,764 **IMPR.:** \$158,858 **TOTAL:** \$241,622

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of wood siding exterior construction with 4,025 square feet of living area. The dwelling was constructed in 1978 and is 43 years old. Features of the home include a crawl-space foundation, central air conditioning, a fireplace, and a garage containing 625 square feet of building area. The property has a 43,877 square foot site and is located in Riverwoods, Vernon Township, Lake County.

The appellant contends assessment inequity with regard to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables located within 1.18 miles of the subject and within the subject's assessment neighborhood. The comparables consist of one-story or two-story dwellings of wood siding or brick exterior construction ranging in size from 3,456 to 4,569 square feet of living area. The homes are 33 to 48 years old. Each dwelling has central air conditioning, one or two fireplaces,

and a garage ranging in size from 576 to 912 square feet of building area. Three comparables each have a basement with one having finished area, and one comparable has a crawl-space foundation. The comparables have improvement assessments ranging from \$132,150 to \$168,098 or from \$35.32 to \$38.74 per square foot of living area. Based on this evidence, the appellant requested a reduced improvement assessment of \$149,931 or \$37.25 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$241,622. The subject property has an improvement assessment of \$158,858 or \$39.47 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on five equity comparables located within 1.56 miles of the subject and within the subject's assessment neighborhood. The comparables consist of two-story dwellings of wood siding, brick, or wood siding and brick exterior construction ranging in size from 3,926 to 4,080 square feet of living area. The homes were built from 1967 to 1998, with comparables #1 and #3 having effective ages of 1980 and 1973, respectively. Each dwelling has central air conditioning, one to three fireplaces, and an attached garage ranging in size from 576 to 864 square feet of building area. Four comparables have basements with three having finished area, and one comparable has a crawl-space foundation. The comparables have improvement assessments ranging from \$136,945 to \$215,169 or from \$34.88 to \$53.60 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity, and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine equity comparables to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to the appellant's comparables #1, #2, and #4 due to differences in age, dwelling size, design, and/or foundation when compared to the subject. The Board also gives reduced weight to board of review comparables #1, #3, #4, and #5 due to differences from the subject in age and/or foundation.

The Board finds the best evidence of assessment equity to be appellant's comparable #3 and board of review comparable #2, which are similar to the subject in age, dwelling size, design, and features. These comparables have improvement assessments of \$136,945 and \$160,471 or \$34.88 and \$35.32 per square foot of living area. The subject's improvement assessment of \$158,858 or \$39.47 per square foot of living area is bracketed by the best comparables in this record overall. While the subject's assessment falls above the best comparables on a per-square-foot basis, the Board finds it logical due to economies of scale which generally provides that as

the size of a property increases, the per unit value decreases, and in contrast, as the size of a property decreases, the per unit value increases. Based on this record and after considering adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

## **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
