

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Jeffrey Skolnik DOCKET NO.: 21-03082.001-R-1 PARCEL NO.: 14-11-105-017

The parties of record before the Property Tax Appeal Board are Jeffrey Skolnik, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$28,418 **IMPR.:** \$131,399 **TOTAL:** \$159,817

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 1-story dwelling of frame exterior construction with 3,136 square feet of living area. The dwelling was built in 1965. Features of the home include an unfinished basement, central air conditioning, one fireplace, and a 441 square foot garage. The property has an approximately 37,414 square foot site and is located in Hawthorn Woods, Ela Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on three equity comparables located in the same assessment neighborhood code as the subject property and within 0.53 of a mile from the subject. The comparables are improved with 1-story dwellings of frame or brick exterior construction ranging in size from 2,434 to 2,970 square feet of living area. The dwellings were built from 1954 to 1963 with comparable #1 having an effective age of

1971. One comparable has an unfinished basement and two comparables were reported to lack basement area. Each comparable has central air conditioning and a garage that ranges in size from 483 to 972 square feet of building area. Two comparables each have one fireplace. The comparables have improvement assessments ranging from \$98,239 to \$110,899 or from \$37.34 to \$40.36 per square foot of living area. Based on this evidence the appellant requested a reduction in the subject's improvement assessment to \$121,833 or \$38.85 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$159,817. The subject property has an improvement assessment of \$131,399 or \$41.90 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on five equity comparables located in the same assessment neighborhood code as the subject property and within 0.67 of a mile from the subject. The comparables are improved with 1-story dwellings of brick or frame exterior construction ranging in size from 2,636 to 3,125 square feet of living area. The dwellings were built from 1968 to 1975 with comparable #5 having an effective age of 1978. Each comparable has an unfinished basement, central air conditioning, one or two fireplaces, and a garage that ranges in size from 548 to 924 square feet of building area. The comparables have improvement assessments ranging from \$116,307 to \$142,716 or from \$42.95 to \$48.66 per square foot of living area.

### **Conclusion of Law**

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of eight comparable properties for the Board's consideration. The Board gives less weight to the appellant's comparables as well as board of review comparable #5 which are less similar to the subject in dwelling size than other comparables in this record and/or lack basement foundations, a feature of the subject.

The Board finds the best evidence of assessment equity to be the four remaining board of review comparables which are similar to the subject in location, design, age, dwelling size, and most features. These comparables have improvement assessments ranging from \$116,307 to \$142,716 or from \$42.95 to \$48.66 per square foot of living area. The subject's improvement assessment of \$131,399 or \$41.90 per square foot of living area falls within the range established by the best comparables in this record on an overall improvement assessment basis but below the range on a per square foot basis. Based on this record and after considering appropriate adjustments to the best comparables for differences from the subject, the Board finds the appellant did not

demonstrate with clear and convincing evidence that the subject's improvement is inequitably assessed and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
