

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Steve Winnike, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$72,898
IMPR.:	\$204,306
TOTAL:	\$277,204

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of brick exterior construction with 4,708 square feet of living area. The dwelling was constructed in 2003 and is approximately 18 years old. Features of the home include a walkout basement, central air conditioning, one fireplace and a 1,004 square foot garage. The property has an approximately 162,177 square foot site and is located in Long Grove, Ela Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables with the same assessment neighborhood code as the subject and located from .62 of a mile to 1.15 miles from the subject. The comparables are improved with two-story dwellings of brick exterior construction that range in size from 4,414 to 5,418 square feet of living area. The homes were built from 1998 to 2004. Each comparable has a basement, central air

conditioning, two or three fireplaces and a garage ranging in size from 925 to 1,338 square feet of building area. The comparables have improvement assessments that range from \$145,423 to \$215,784 or from \$27.66 to \$42.33 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$175,420 or \$37.26 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$277,204. The subject has an improvement assessment of \$204,306 or \$43.40 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on five equity comparables with the same assessment neighborhood code as the subject and located from .06 of a mile to 1.33 miles from the subject. The comparables are improved with two-story dwellings of brick or concrete block exterior construction that range in size from 4,304 to 4,959 square feet of living area. The homes were built from 2000 to 2006. Each comparable has a basement, central air conditioning, one to four fireplaces and a garage ranging in size from 757 to 968 square feet of building area. The comparables have improvement assessments that range from \$200,998 to \$226,266 or from \$43.08 to \$52.57 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

# **Conclusion of Law**

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments, for the assessment year in question, of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted nine equity comparables for the Board's consideration. The Board gives less weight to the appellant's comparable #1 which appears to be an outlier with its considerably lower improvement assessment relative to the other comparables in the record. The Board also gives less weight to the appellant comparables #2 and #4 along with board of review comparables #1 and #4 due to differences in location and/or dwelling size when compared to the subject.

The Board finds the best evidence of assessment equity to be the parties' remaining comparables. These comparables are relatively similar to the subject in location, age, dwelling size and other features. These four comparables have improvement assessments that range from \$189,493 to \$226,266 or from \$39.22 to \$52.57 per square foot of living area. The subject's improvement assessment of \$204,306 or \$43.40 per square foot of living area falls within the range established by the best comparables in this record. After considering appropriate adjustments to the best comparables for differences from the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
