

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Yan Guo, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$47,356
IMPR.:	\$156,466
TOTAL:	\$203,822

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction with 3,140 square feet of living area. The dwelling was constructed in 1985 and is approximately 36 years old. Features of the home include a basement with finished area, central air conditioning, a fireplace, and a garage containing 408 square feet of building area. The property has a 20,037 square foot site and is located in Lincolnshire, Vernon Township, Lake County.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables located within .35 of a mile of the subject and within the subject's assessment neighborhood. The comparables consist of two-story dwellings of wood siding exterior construction ranging in size from 2,814 to 3,174 square feet of living area. The homes are 34 to 46 years old. Each dwelling has central air conditioning, a fireplace, a basement with finished area, and a garage ranging in size from 483 to

555 square feet of building area. The comparables have improvement assessments ranging from \$124,016 to \$144,532 or from \$44.07 to \$45.54 per square foot of living area. Based on this evidence, the appellant requested a reduced improvement assessment of \$140,986 or \$44.90 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$203,822. The subject property has an improvement assessment of \$156,466 or \$49.83 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on five equity comparables located within .36 of a mile of the subject and within the subject's assessment neighborhood. The comparables consist of two-story dwellings of brick or wood siding and brick exterior construction ranging in size from 3,089 to 3,135 square feet of living area. The homes were built from 1972 to 1987, with the oldest home having an effective age of 1973. Each dwelling has central air conditioning, one or two fireplaces, a basement with four having finished area, and a garage ranging in size from 462 to 726 square feet of building area. The comparables have improvement assessments ranging from \$156,185 to \$173,297 or from \$49.93 to \$56.08 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.


Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity, and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine equity comparables to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to the appellant's comparable #1, as well as board of review comparable #4, due to their older dwellings in relation to the subject.

The Board finds the best evidence of assessment equity to be appellant's comparables #2 through #4 and board of review comparables #1, #2, #, and #5, which are similar to the subject in age, location, dwelling size, and features. These comparables had improvement assessments that ranged from \$133,718 to \$173,297 or from \$44.52 to \$56.08 per square foot of living area. The subject's improvement assessment of \$156,466 or \$49.83 per square foot of living area falls within the range established by the best comparables in this record. Based on this record and after considering adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
