



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Boris Liokumovich

The parties of record before the Property Tax Appeal Board are Boris Liokumovich, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$57,632
IMPR.: \$80,183
TOTAL: \$137,815

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of wood siding exterior construction with 1,956 square feet of living area. The dwelling was built in 1972 and is approximately 49 years old. Features of the property include an unfinished basement, central air conditioning, one fireplace, and a garage with 441 square feet of building area. The property has an approximately 10,001 square foot site and is located in Libertyville, Libertyville Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on four comparable sales located in the same assessment neighborhood code as the subject property and within 0.28 of a mile from the subject. The comparables have sites that range in size from 10,624 to 13,995 square feet of land area. The comparables are improved with 2-story dwellings of wood siding exterior construction ranging in size from 1,948 to 2,300 square feet of living area. The dwellings range in age from 46 to 48

years old. Each comparable has an unfinished basement, central air conditioning, one fireplace, and a garage with 441 square feet of building area. The properties sold from March 2019 to April 2021 for prices ranging from \$355,000 to \$433,000 or from \$182.24 to \$188.26 per square foot of living area, land included. Based on this evidence, the appellant requested the subject's assessment be reduced to \$120,484 which reflects a market value of \$361,488 or \$184.81 per square foot of living area, land included, when applying the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$137,815. The subject's assessment reflects a market value of \$414,481 or \$211.90 per square foot of living area, including land, when using the 2021 three-year average median level of assessment for Lake County of 33.25% as determined by the Illinois Department of Revenue. In support of its contention of the correct assessment, the board of review submitted information on five comparable sales located in the same assessment neighborhood code as the subject property and within 0.20 of a mile from the subject. The comparables have sites that range in size from 10,000 to 12,870 square feet of land area. The comparables are improved with 2-story dwellings of wood siding exterior construction ranging in size from 1,948 to 2,222 square feet of living area. Each comparable has an unfinished basement, one fireplace, and a garage that ranges in size from 431 to 462 square feet of building area. Four comparables each have central air conditioning. The properties sold from August 2020 to October 2021 for prices ranging from \$437,500 to \$540,000 or from \$224.59 to \$243.02 per square foot of living area, land included. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains nine comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparable #1 and #2 which have 2019 sale dates occurring less proximate in time to the subject's January 1, 2021 assessment date at issue than other comparables in this record and/or which differs from the subject in dwelling size. The Board finds the evidence of market value to be the parties' remaining comparables which sold proximate in time to the subject's assessment date at issue and are similar to the subject in location, design, age, dwelling size, and most features. These properties sold from August 2020 to October 2021 for prices ranging from \$360,000 to \$540,000 or from \$182.65 to \$243.02 per square foot of living area, land included. The subject's assessment reflects an estimated market value of \$414,481 or \$211.90 per square foot of living area, land included, which falls within the range established by the best comparable sales in this record. Based on this record and after considering adjustments to the best comparables for differences from the subject, the Board finds the subject's estimated market value as reflected by its assessment is supported and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
