



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Chandra Ramesh & Ramesh Sundaram

The parties of record before the Property Tax Appeal Board are Chandra Ramesh & Ramesh Sundaram, the appellants, by Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds No Change in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$21,359
IMPR.: \$84,412
TOTAL: \$105,771

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of vinyl siding exterior construction with 2,051 square feet of living area. The dwelling was constructed in 1995. Features of the home include a basement with finished area, central air conditioning, a fireplace and a 400 square foot garage. The property has an approximately 9,150 square foot site and is located in Mundelein, Fremont Township, Lake County.

The appellants contend overvaluation as the basis of the appeal. In support of this argument, the appellants submitted information on three comparable sales located within .47 of a mile from the subject property. The comparables are reported to have sites of either 7,405 or 10,018 square feet of land area. The comparables are improved with 2-story dwellings of vinyl siding exterior construction ranging in size from 1,962 to 2,047 square feet of living area that were built in either 1995 or 1997. Two comparables are reported to have a basement. Each comparable has central air conditioning and a garage ranging in size from 400 to 441 square feet of building area. Two comparables each have a fireplace. The comparables sold from August to November 2020

for prices ranging from \$275,000 to \$309,000 or from \$140.16 to \$150.95 per square foot of living area, including land. Based on this evidence, the appellants requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$105,771. The subject's assessment reflects a market value of \$318,108 or \$155.10 per square foot of living area, land included, when using the 2021 three-year average median level of assessment for Lake County of 33.25% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on five comparable sales located within .42 of a mile and in the same neighborhood code as the subject. Comparable #2 is the same property as the appellants' comparable #1. The comparables have sites of either 7,410 or 8,710 square feet of land area. The comparables are improved with 2-story dwellings of vinyl siding exterior construction ranging in size from 1,815 to 2,212 square feet of living area. The dwellings were built from 1994 to 1997. Each comparable is reported to have a basement, two with finished area, central air conditioning and a garage ranging in size from 400 to 482 square feet of building area. Two comparables each have a fireplace. The comparables sold from July 2021 to February 2022 for prices ranging from \$347,500 to \$400,000 or from \$174.99 to \$191.46 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight suggested comparable sales for the Board's consideration, with one comparable being common to both parties. The Board has given less weight to board of review comparable #5 due to its smaller dwelling size when compared to the subject. The Board gave reduced weight to board of review comparable #4 due to its sale date occurring in 2022, which is less proximate to the January 1, 2021 assessment date than other comparables in the record.

The Board finds the best evidence of market value to be the appellants' comparables along with the board of review comparables #1, #2 and #3, which includes the common comparable. The Board finds these comparables are similar to the subject in location, design, age, dwelling size and some features. The comparables sold for prices ranging from \$275,000 to \$400,000 or from \$140.16 to \$191.02 per square foot of living area, including land. The subject's assessment reflects a market value of \$318,108 or \$155.10 per square foot of living area, including land, which falls within the range of the best comparable sales in the record. Based on this record and after considering adjustments to the best comparables for differences when compared to the subject, the Board finds no reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
