

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Manuel Hernandez DOCKET NO.: 21-04172.001-R-1 PARCEL NO.: 06-29-210-008

The parties of record before the Property Tax Appeal Board are Manuel Hernandez, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Hawthorn Woods; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$6,841 **IMPR.:** \$59,456 **TOTAL:** \$66,297

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a tri-level dwelling of vinyl siding exterior construction with 1,236 square feet of above grade living area. The dwelling was constructed in 1994. Features of the home include a lower level with finished area, central air conditioning and a 440 square foot garage. The property has an approximately 5,000 square foot site and is located in Round Lake, Avon Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on three comparable sales located within 0.58 of a mile from the subject property. Two of the comparables are located in the same assessment neighborhood as the subject. The comparables have sites that range in size from 4,356 to 6,098 square feet of

land area and are reported to be improved with one-story dwellings¹ ranging in size from 1,014 to 1,254 square feet of above grade living area. The dwellings were built in 1987 or 2004 with comparable #2 having an effective age of 1993. Two comparables have central air conditioning and one comparable has a 440 square foot garage. The properties sold from January 2020 to May 2021 for prices ranging from \$146,500 to \$225,000 or from \$144.48 to \$179.43 per square foot of above grade living area, land included. Based on this evidence, the appellant requested the subject's total assessment be reduced to \$64,678 which reflects a market value of \$194,053 or \$157.00 per square foot of above grade living area, land included, when applying the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$66,297. The subject's assessment reflects a market value of \$199,389 or \$161.32 per square foot of above grade living area, land included, when using the 2021 three-year average median level of assessment for Lake County of 33.25% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales located within 0.25 of a mile from the subject property. Board of review comparable #4 is the same property as the appellant's comparable #3. The comparables have sites that range in size from 4,630 to 9,540 square feet of land area and are improved with tri-level dwellings of vinyl siding exterior construction ranging in size from 1,210 to 1,254 square feet of above grade living area. The homes were built from 1992 to 2004. Each comparable has a lower level with finished area and comparable #3 has an unfinished basement. Each dwelling has central air conditioning and a garage ranging in size from 400 to 528 square feet of building area. One home has a fireplace. The properties sold from April to November 2021 for prices ranging from \$200,000 to \$225,000 or from \$164.26 to \$180.87 per square foot of above grade living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales, or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains six comparable sales for the Board's consideration, as one property was common to both parties. The Board gives less weight to appellant comparables #1 and #2 which differ from the subject in design, dwelling size and lack a garage amenity. The Board gives less weight to board of review comparable #3 which has a basement unlike the subject.

¹ The appellant's comparable #3 was also submitted by the board of review which described this dwelling to be a trilevel style home with a finished lower level.

The Board finds the best evidence of market value to be appellant comparable #3 along with board of review comparables #1, #2 and #4, including the common property, which are more similar to the subject in location, age, design, dwelling size and other features. These best comparables sold from May to November 2021 for prices of \$200,000 and \$225,000 or from \$165.29 to \$180.87 per square foot of above grade living area, including land. The subject's assessment reflects a market value of \$199,389 or \$161.32 per square foot of above grade living area, including land, which falls below the range established by the best comparable sales in this record. After considering appropriate adjustments to the comparables for differences from the subject, the Board finds the subject's assessment is justified and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
