



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Richard Hillsberg

The parties of record before the Property Tax Appeal Board are Richard Hillsberg, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$85,148  
**IMPR.:** \$66,697  
**TOTAL:** \$151,845

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a 1-story dwelling of stucco exterior construction with 2,259 square feet of living area. The dwelling was constructed in 1961. Features of the home include a slab foundation, central air conditioning and an attached 437 square foot garage. The property has an approximately 13,040 square foot site and is located in Highland Park, Moraine Township, Lake County

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on three comparable sales that are located from .16 of a mile to 2.15 miles from the subject. The comparables have sites ranging in size from 12,750 to 38,311 square feet of land area that are improved with 1-story dwellings ranging in size from 1,952 to 2,268 square feet of living area. The dwellings were built from 1958 to 1966 and do not have basements. The comparables have central air conditioning and a garage ranging in size from 460

to 836 square feet of building area. Two comparables each have a fireplace. The comparables sold from June to August 2020 for prices ranging from \$375,000 to \$470,000 or from \$186.57 to \$240.78 per square foot of living area, including land. Based on this evidence the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$151,845. The subject's assessment reflects a market value of \$456,677 or \$202.16 per square foot of living area, land included, when using the 2021 three-year average median level of assessment for Lake County of 33.25% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on five comparable sales that are located from .04 to .32 of a mile from the subject. The board of review's comparable #4 is the same property as the appellant's comparable #2. The comparables have sites ranging in size from 12,220 to 17,660 square feet of land area that are improved with 1-story dwellings of brick, wood siding or brick and wood siding exterior construction ranging in size from 2,040 to 2,891 square feet of living area. The dwellings were built from 1949 to 1967, with homes built in 1949 and 1954 having 1970 and 1973 effective ages. Three comparables have basements, two of which have finished area, and two comparables have crawl-space foundations. The comparables have central air conditioning and an attached garage ranging in size from 378 to 564 square feet of building area. Three comparables each have one or two fireplaces. The comparables sold from July 2020 to September 2021 for prices ranging from \$426,000 to \$784,270 or from \$187.83 to \$331.62 per square foot of living area, including land. Based on this evidence the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of seven comparable sales for the Board's consideration, one of which was submitted by both parties. The Board gives less weight to the board of review's comparables #2, #3 and #5, due to their finished basement area and/or their basement foundation when compared to the subject. The Board finds the parties' remaining comparables, which includes the parties' common comparable, have varying degrees of similarity to the subject. However, two of the appellant's comparables are located over a mile from the subject. Nevertheless, the best comparables sold from June to August 2020 for prices ranging from \$375,000 to \$470,000 or from \$186.57 to \$240.78 per square foot of living area, including land. The subject's assessment reflects a market value of \$456,677 or \$202.16 per square foot of living area, including land, which falls within the range established by the best comparables in the record. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the subject's estimated market value as reflected by its assessment is supported and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
