



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: William & Susan Korver

The parties of record before the Property Tax Appeal Board are William & Susan Korver, the appellants, by Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the DuPage County Board of Review.¹

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$30,890
IMPR.: \$121,720
TOTAL: \$152,610

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of frame and masonry exterior construction with 2,128 square feet of living area. The dwelling was constructed in 1952. Features of the home include a basement, central air conditioning, a fireplace and a 440 square foot garage. The property has a 10,794 square foot site and is located in Wheaton, Milton Township, DuPage County.

The appellants contend overvaluation as the basis of the appeal. In support of this argument the appellants submitted information on five comparable sales located within the same assessment neighborhood code as the subject and within .83 of a mile from the subject. These comparables are described as 2-story dwellings built from 1955 to 1977 that range in size from 1,998 to 2,261

square feet of living area. The comparables each have a basement, two of which have finished area. Each comparable also has central air conditioning and a garage ranging in size from 441 to 504 square feet of building area. The comparables sold from September 2020 to November 2021 for prices ranging from \$400,000 to \$532,500 or from \$190.66 to \$235.52 per square foot of living area, land included. Based on this evidence, the appellants requested a reduction in the subject's total assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$185,270. The subject's assessment reflects a market value of \$554,203 or \$260.43 per square foot of living area, land included, when using the 2021 three-year average median level of assessment for DuPage County of 33.43% as determined by the Illinois Department of Revenue.

In response to the appellants' appeal, the board of review submitted information on the appellants' comparable sales. The board of review argued appellants' comparables #4 and #5 are not similar to the subject due to their location that is across Roosevelt Road (see map).

In support of its contention of the correct assessment the board of review submitted information prepared by the township assessor on four comparable sales located within 1.13 miles from the subject and within the same assessment neighborhood code as the subject. The comparables are reported to have sites ranging in size from approximately 8,472 to 10,944 square feet of land area and are improved with 2-story dwellings of frame or frame and masonry exterior construction built from 1911 to 1951. The dwellings range in size from 1,806 to 2,314 square feet of living area and have basements, two of which have finished area. Three comparables have central air conditioning. Each comparable has one fireplace and a garage ranging in size from 240 to 528 square feet of building area. The comparables sold from February 2019 to July 2021 for prices ranging from \$512,500 to \$630,000 or from \$259.72 to \$336.54 per square foot of living area, land included. The board of review also submitted a map depicting the locations of both parties' comparable sales in relation to the subject along with property record cards and exterior photographs. Based on this evidence, the board of review requested confirmation of the subject's assessment.

In written rebuttal, counsel for the appellants' contended that the board of review comparables are not comparable due to differences in location, age, dwelling size, finished basement area and/or remote sale date.

Conclusion of Law

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the parties submitted nine comparable sales to support their respective positions. The Board gives less weight to appellants' comparables #1 and #3 as well as board of review

comparables #2 and #4 which have finished basement area when compared to the subject. The Board gives less weight to board of review comparable #1 due to difference in age when compared to the subject. Reduced weight was also given to board of review comparable #3 as it sold less proximate in time to the assessment date at issue than the other sales in the record.

The Board finds the best evidence of market value to be appellants' comparable sales #2, #4 and #5 which sold proximate in time to the assessment date at issue and are relatively similar to the subject in age, dwelling size and features. These comparables sold from September 2020 to September 2021 for prices ranging from \$400,000 to \$532,500 or from \$190.66 to \$235.52 per square foot of living area, including land. The subject's assessment reflects a market value of \$554,203 or \$260.43 per square foot of living area, including land, which falls above the range established by the best comparable sales in this record. Based on this record and after considering adjustments to the best comparable sales for differences when compared to the subject, the Board finds a reduction in the subject's assessment commensurate with the appellants' request is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
