



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Heriberto Chaidez

The parties of record before the Property Tax Appeal Board are Heriberto Chaidez, the appellant, by Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the DuPage County Board of Review.¹

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds ***no change*** in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$51,380
IMPR.: \$113,740
TOTAL: \$165,120

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of brick and frame exterior construction with 3,058 square feet of living area. The dwelling was constructed in 1988. Features of the home include a basement, central air conditioning, a fireplace, and a garage containing 952 square feet of building area. The property has an 8,520 square foot site and is located in Addison, Addison Township, DuPage County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on seven comparable sales with the same assessment neighborhood code as the subject and located within .14 of a mile from the subject. These comparables are described as 2-story dwellings built in 1988 or 1989 and range in size from

3,102 to 3,420 square feet of living area. Each comparable has a basement, central air conditioning, one or two fireplaces, and a garage ranging in size from 462 to 704 square feet of building area. The comparables sold from June 2020 to November 2021 for prices ranging from \$382,000 to \$499,900 or from \$111.70 to \$153.13 per square foot of living area, land included. Based on this evidence, the appellant requested a reduction in the subject's total assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$165,120. The subject's assessment reflects a market value of \$493,928 or \$161.52 per square foot of living area, land included, when using the 2021 three-year average median level of assessment for DuPage County of 33.43% as determined by the Illinois Department of Revenue.

In response to the appellant's evidence, the board of review submitted a comparable report containing 6 of the 7 appellant's comparable sales that disclosed sites ranging in size from 7,847 to 10,880 square feet of land area that were not reported by the appellant.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales with same assessment neighborhood code as the subject that was prepared by the township assessor. Comparable #3 is a duplicate of appellant's comparable #2. The comparables are described as 2-story dwellings of brick or brick and frame exterior construction built in 1988 or 1989. The dwellings range in size from 3,306 to 3,529 square feet of living area. The comparables each have a basement, central air conditioning, one or two fireplaces and a garage ranging in size from 484 to 682 square feet of building area. The comparables are reported to have sites ranging in size from 6,888 to 9,840 square feet of land area. The comparables sold from February 2018 to October 2020 for prices ranging from \$475,000 to \$550,000 or from \$143.68 to \$161.97 per square foot of living area, land included. The board of review also provided a location map of the board of review comparables and six of the appellant's comparables in relation to the subject property, property record cards and exterior photographs. Based on this evidence, the board of review requested confirmation of the subject's assessment.

In written rebuttal, counsel for the appellant contended that board of review comparables #1, #2 and #4 are not comparable to the subject due to their remote sale dates. In a rebuttal grid analysis, counsel suggested that the appellant's comparables are the best comparable sales in the record and contended the subject's assessment should be reduced.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the parties submitted ten comparables sales to support their respective positions which includes the common comparable. The Board gives less weight to appellant's comparable

#7 which appears to be an outlier as it sold considerably less than the other sales in the record. The Board gives less weight to board of review comparables #1, #2 and #4 as their sale dates occurred in 2018 and 2019 which are less proximate in time to the January 1, 2021 assessment than the other sales in the record.

The Board finds the best evidence of market value to be the appellant's comparables #1 through #6 which includes the common comparable. These comparables sold proximate in time to the assessment date at issue and are relatively similar to the subject in location, age, dwelling size and some features. These comparables sold from October 2020 to November 2021 for prices ranging from \$440,000 to \$499,900 or from \$128.92 to \$153.13 per square foot of living area, including land. The subject's assessment reflects a market value of \$493,928 or \$161.52 per square foot of living area, including land, which falls within the range established by the best comparables sales in this record on overall market value but above the range on price per square foot. The subject property's higher value on a square foot basis is justified in part based on its smaller dwelling size in relation to the comparable dwellings and the concept of economies of scale. Furthermore, the subject has a larger garage than the best comparables in the record. Therefore, after considering adjustments to the best comparables for differences when compared to the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
