

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: John J. Thompson DOCKET NO.: 21-07290.001-R-1 PARCEL NO.: 07-07-301-020

The parties of record before the Property Tax Appeal Board are John J. Thompson, the appellant, by Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the DuPage County Board of Review.¹

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$44,020 **IMPR.:** \$148,360 **TOTAL:** \$192,380

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of frame and brick exterior construction with 3,296 square feet of living area. The dwelling was constructed in 1998. Features of the home include a basement, central air conditioning, a fireplace, and a 2-car garage with 710 square feet of building area. The property has an approximately 12,054 square foot site and is located in Aurora, Naperville Township, DuPage County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales located within the same neighborhood as the subject and within .20 of a mile from the subject. These comparables are described as 2-

story dwellings built from 1992 to 2001 and range in size from 3,051 to 3,665 square feet of living area. Each comparable has a basement, central air conditioning, and a 2-car or 3-car garage. The comparables sold from February 2020 to January 2021 for prices ranging from \$415,000 to \$517,500 or from \$126.53 to \$141.59 per square foot of living area, land included. Based on this evidence, the appellant requested a reduction in the subject's total assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$192,380. The subject's assessment reflects a market value of \$575,471 or \$174.60 per square foot of living area, land included, when using the 2021 three-year average median level of assessment for DuPage County of 33.43% as determined by the Illinois Department of Revenue.

In response to the appellant's evidence, the board of review submitted a comparable report spreadsheet of the appellant's comparable sales that disclosed each dwelling has a frame or frame and brick exterior, a fireplace and a garage ranging in size from 462 to 692 square feet of building area that were not reported by the appellant. Comparables #1, #3 and #4 have sites ranging in size from approximately 10,033 to 14,880 square feet of land area that were not reported by the appellant. The assessor also noted comparables #1 and #4 have considerably less garage square footage than the subject.

In support of its contention of the correct assessment the board of review submitted information prepared by the township assessor on six comparable sales, two of which have the same assessment neighborhood code as the subject. The comparables are described as 2-story dwellings of frame or frame and brick exterior construction built from 1991 to 2002. The dwellings range in size from 2,955 to 3,786 square feet of living area and have basements, one of which has finished area. Each comparable has central air conditioning, one fireplace and a 3-car garage ranging in size from 594 to 692 square feet of building area. The comparables are reported to have sites ranging in size from approximately 12,100 to 26,387 square feet of land area. The comparables sold from October 2020 to June 2021 for prices ranging from \$561,000 to \$700,000 or from \$158.48 to \$196.96 per square foot of living area, land included. The board of review also provided a location map of the board of review comparables and the appellant's comparables in relation to the subject property along with property record cards and exterior photographs. Based on this evidence, the board of review requested confirmation of the subject's assessment.

In written rebuttal, counsel for the appellant contended that the board of review comparables are not comparable to the subject due to location in a different neighborhood and/or larger garage. In a rebuttal grid analysis, counsel suggested that the appellant's comparables #1 and #3 are the best comparable sales in the record and contended the subject's assessment should be reduced.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or

construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the parties submitted ten comparables sales to support their respective positions. The Board gives less weight to appellant's comparables #1 and #4 which have a smaller garage with either 462 or 492 square feet when compared to the subject's 710 square foot garage. The Board gives less weight to board of review comparable #2 which has finished basement area unlike the subject and to board of review comparables #4, #5 and #6 which are located less proximate to the subject than the other comparables in the record.

The Board finds the best evidence of market value to be the appellant's comparables #2 and #3 as well as board of review comparables #1 and #3. These comparables are relatively similar to the subject in location, age, dwelling size and some features. These comparables sold from January 2020 to June 2021 for prices ranging from \$455,000 to \$700,000 or from \$126.53 to \$196.96 per square foot of living area, including land. The subject's assessment reflects a market value of \$575,471 or \$174.60 per square foot of living area, including land, which falls within the range established by the best comparables sales in this record. Therefore, after considering adjustments to the best comparables for differences when compared to the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
