



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Cristian Drimboi

The parties of record before the Property Tax Appeal Board are Cristian Drimboi, the appellant, by attorney Andreas Mamalakis, of the Law Offices of Andreas Mamalakis in Kenosha; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$4,384
IMPR.: \$11,695
TOTAL: \$16,079

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 1-story dwelling of masonry exterior construction with 1,141 square feet of living area. The dwelling is approximately 55 years old. Features of the home include a full basement, 1½ bathroom and a 2.5-car garage.¹ The property has a 7,015 square foot site and is located in Des Plaines, Maine Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five comparables

located within the subject's assessment neighborhood in Des Plaines, Illinois and from 0.30 to 0.83 of a mile from the subject. The comparables consist of class 2-03, 1-story dwellings of masonry exterior construction ranging in size from 1,100 to 1,265 square feet of living area. The dwellings are 69 or 70 years old. Four comparables each have a slab foundation, and one comparable has a full basement with finished area. Each comparable has 1 or 2½ bathrooms, 1 or 2 fireplaces, and either a 1-car, a 1.5-car or a 2-car garage. The comparables have improvement assessments ranging from \$10,500 to \$12,428 or from \$9.22 to \$9.82 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject property of \$25,116. The subject property has an improvement assessment of \$20,732 or \$18.17 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four comparables located in Park Ridge, Illinois and within a different assessment neighborhood than the subject property. The comparables consist of class 2-03, 1-story dwellings of masonry exterior construction ranging in size from 1,291 to 1,559 square feet of living area. The comparables are 54 to 68 years old. Each comparable has a partial or a full basement with three having finished area, 1½, 2 or 2½ bathrooms and a 1-car or a 2-car garage. Three comparables each have central air conditioning, and two comparables have 1 or 2 fireplaces. The comparables have improvement assessments ranging from \$31,576 to \$34,308 or from \$20.84 to \$26.00 per square foot of living area. Based on this evidence, the board of review requested the assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted nine comparable properties for the Board's consideration. The Board finds the comparables have varying degrees of similarity to the subject in location, age, bathroom count, dwelling size, foundation type and/or other features. Nonetheless, the Board gives less weight to the board of review's comparables that are located within a different assessment neighborhood and city than the subject property and also differ from the subject in dwelling size and/or age. The Board gives more weight to the appellant's comparables that are located within the same assessment neighborhood and city as the subject and are also similar to the subject in design and dwelling size. However, these comparables are inferior to the subject due to significant differences in their older aged dwellings, lack of a basement foundation and/or other features. Nevertheless, these five comparables have improvement assessments ranging from \$10,500 to \$12,428 or from \$9.22 to \$9.82 per square foot of living area. The subject's improvement assessment of \$20,732 or \$18.17 per square foot of living area falls above the range established by the best comparables in the record. After considering adjustments to the

best comparables in the record for differences from the subject, the Board finds the subject's assessment is excessive. Based on this record, the Board finds the appellant demonstrated with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
