

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Joshua Metz, the appellant, by attorney Ciarra J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$52,412 **IMPR.:** \$56,625 **TOTAL:** \$109,037

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of masonry exterior construction with 2,462 square feet of living area. The dwelling is approximately 17 years old. Features of the home include a basement with finished area, central air conditioning, three fireplaces and a 2-car garage. The property has an approximately 2,995 square foot site and is located in Chicago, Lake View Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted Property Search Details and a grid analysis with information on five equity comparables located in the same assessment

neighborhood code as the subject property. The comparables are improved with 2-story¹ class 2-78 dwellings of masonry exterior construction ranging in size from 2,578 to 2,669 square feet of living area each of which are 19 years old. Each comparable has a basement with finished area, central air conditioning, one fireplace and a 3.5-car garage. The comparables have improvement assessments ranging from \$55,068 to \$57,068 or from \$20.63 to \$22.14 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$53,031 or \$21.54 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$126,592. The subject property has an improvement assessment of \$74,180 or \$30.13 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparables, two of which are located in the same assessment neighborhood code as the subject property. The comparables are improved with 2-story or 3-story class 2-78 dwellings of frame or masonry exterior construction ranging in size from 2,720 to 3,791 square feet of living area that are 10 or 15 years old. Each comparable has a basement with finished area, central air conditioning, two or three fireplaces and a 2-car garage. The comparables have improvement assessments ranging from \$89,570 to \$115,312 or from \$30.42 to \$32.93 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted nine equity comparables for the Board's consideration. The Board gives less weight to each of the board of review's comparables which differ from the subject in location, design and/or dwelling size.

The Board finds the best evidence of assessment equity to be the appellant comparables which are more similar to the subject in location, age, design, dwelling size and most features. These comparables have improvement assessments ranging from \$55,068 to \$57,068 or from \$20.63 to \$22.14 per square foot of living area. The subject's improvement assessment of \$74,180 or \$30.13 per square foot of living area falls above the range established by the best comparables in this record. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant demonstrated with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is justified.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

Docket No: 21-36685.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
