

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Brian Stal

The parties of record before the Property Tax Appeal Board are Brian Stal, the appellant, by attorney Dora Cornelio, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$39,062 **IMPR.:** \$96,689 **TOTAL:** \$135,751

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 2-story dwelling of frame construction with 3,107 square feet of living area which is approximately 2 years old. Features of the home include 4½ baths, a full basement finished with formal recreation room, central air conditioning, and a 2-car garage. The property has a 3,125 square foot site and is located in Chicago, Lake View Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five equity

comparables located in the same assessment neighborhood code as the subject property. The comparables consist of 2-story class 2-78 dwellings of frame or masonry construction ranging in size from 2,816 to 3,113 square feet of living area and ranging in age from approximately 16 to 25 years old. The comparables are described as having two to four full baths with each dwelling having an additional ½ bath. Four comparables each have a full basement, three of which are finished with formal recreation room. Each comparable also has central air conditioning. Three comparables each have one or two fireplaces, and four comparables have a 3.5-car or a "6 or more"-car garage. The comparables have improvement assessments that range from \$53,750 to \$64,413 or from \$17.27 to \$21.94 per square foot of living area. The appellant also submitted a brief and the property information sheets from the Cook County Assessor's database for each comparable property. Based on this evidence, the appellant requested a reduction to the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$135,751. The subject property has an improvement assessment of \$96,689 or \$31.12 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located within ¼ of a mile or within the "same block" as the subject, and within the same assessment neighborhood code as the subject property. The comparables consist of 2-story class 2-78 dwellings of frame or masonry construction ranging in size from 2,672 to 2,822 square feet of living area and are either 7 or 10 years old. Each comparable features either three or four full baths and one or two ½ baths. Each dwelling has a full basement finished with formal recreation room, central air conditioning, two fireplaces, and a 2-car garage. The comparables have improvement assessments ranging from \$84,435 to \$102,015 or from \$31.60 to \$36.15 per square foot of living area.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine equity comparables in support of their positions before the Property Tax Appeal Board. The Board gives less weight to appellant's comparables #1, #3, and #4 based on having an unfinished basement, lacking a garage, and lacking a basement, respectively, all dissimilar to the subject property. The Board finds that remaining comparables in this record are similar to the subject in location, design, class, and most characteristics. However, each of the best comparables in the record is older in age and is smaller in dwelling size relative to the subject dwelling, suggesting that upward adjustments are necessary to the best comparables in order to make them more equivalent to the subject. Nevertheless, the best comparables contained in this record have improvement assessments ranging from \$55,276 to \$102,015 or from \$19.63 to \$36.15 per square foot of living area. The subject's improvement

assessment of \$96,689 or \$31.12 per square foot of living area falls within the range established by the best comparables in this record.

After considering adjustments to the best comparables for differences from the subject such as older ages and smaller dwelling sizes, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement is inequitably assessed and, therefore, a reduction in the subject's improvement assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

# **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
