



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Leah Holt

The parties of record before the Property Tax Appeal Board are Leah Holt, the appellant, by attorney Brianna L. Golan, of Golan Christie Taglia LLP in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$41,328
IMPR.: \$30,672
TOTAL: \$72,000

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of stucco exterior construction with 1,630 square feet of living area. The dwelling is approximately 120 years old. Features of the home include an unfinished basement, 1½-bathrooms, central air conditioning and a 2-car garage.¹ The property has an approximately 5,166 square foot site and is located in Chicago, Lake View Township, Cook County. The subject is classified as a class 2-05 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted property search details, a Uniformity Comparison Sheet and a grid analysis with information on six equity comparables located in the

same assessment neighborhood code as the subject property. The comparables are improved with class 2-05 dwellings of frame or stucco exterior construction ranging in size from 1,540 to 2,086 square feet of living area. The homes range in age from 120 to 135 years old. Each comparable has a basement, with two having finished area. Each comparable has either 1½ or 2 bathrooms. One dwelling has central air conditioning,² two homes have either one or two fireplaces and each comparable has either a 1-car or a 2-car garage. The comparables have improvement assessments ranging from \$19,160 to \$28,453 or from \$12.05 to \$13.80 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$21,206 or \$13.01 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$72,000. The subject property has an improvement assessment of \$30,672 or \$18.82 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparables located in the same assessment neighborhood code as the subject property. The comparables are improved with 2-story class 2-05 dwellings of frame exterior construction ranging in size from 1,600 to 1,754 square feet of living area. The homes range in age from 133 to 153 years old. Each comparable has an unfinished basement, 1½, 2 or 2½ bathrooms and a 1.5-car or a 2-car garage. Two dwellings have central air conditioning and one home has a fireplace. The comparables have improvement assessments ranging from \$31,236 to \$48,744 or from \$19.00 to \$29.10 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted ten equity comparables for the Board's consideration. The appellant's comparables are more similar to the subject in age but are less similar to the subject in dwelling size. In contrast, the board of review's comparables are more similar to the subject in dwelling size but are less similar to the subject in age. Nevertheless, the Board gives less weight to appellant comparables #1, #4, #5 and #6 which are less similar to the subject in dwelling size. The Board also gives less weight to board of review comparables #1, #3 and #4 which differ from the subject in age and/or have an additional full bathroom relative to the subject.

The Board finds the best evidence of assessment equity to be appellant comparables #2 and #3 and board of review comparable #2 which are more similar to the subject in location, age, design and dwelling size. However, these comparables present varying degrees of similarity to the

subject in bathroom count, garage capacity and presence of central air conditioning, suggesting adjustments are needed to make these properties more equivalent to the subject. These best comparables have improvement assessments ranging from \$19,160 to \$31,236 or from \$12.24 to \$19.00 per square foot of living area. The subject's improvement assessment of \$30,672 or \$18.82 per square foot of living area falls within the range established by the best comparables in this record. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
