



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Konstaninos Hatzitaskos

The parties of record before the Property Tax Appeal Board are Konstaninos Hatzitaskos, the appellant, by attorney Abby L. Strauss, of Schiller Law P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$54,250
IMPR.: \$95,992
TOTAL: \$150,242

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of frame exterior construction with 2,704 square feet of living area. The home is approximately 10 years old. Features of the home include a full basement with finished area, central air conditioning, three fireplaces, and a 2-car garage. The property has a 3,100 square foot site and is located in Chicago, Lake View Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables that are located in the subject's assessment neighborhood code. The comparables are improved with class 2-78 dwellings of frame exterior construction ranging in size from 2,620 to 2,790 square feet of living area. The homes range in age from 12 to 23 years old. The

comparables each have a full or partial basement, central air conditioning, either one or two fireplaces, and a 2-car garage. The comparables have improvement assessments ranging from \$52,643 to \$74,453 or from \$19.57 to \$27.99 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced to \$63,814 or \$23.60 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$150,242. The subject property has an improvement assessment of \$95,992 or \$35.50 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables that are located within the same assessment neighborhood code as the subject property. The comparables are improved with 2-story, class 2-78 dwellings of frame exterior construction ranging in size from 2,762 to 3,320 square feet of living area. The homes are either 3 or 10 years old. Each comparable has a full basement with finished area, central air conditioning, and either one or two fireplaces. Two comparables each have a 2-car garage. The comparables have improvement assessments ranging from \$96,019 to \$113,909 or from \$33.64 to \$35.42 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

In written rebuttal, the appellant pointed out the difference in living area between the subject property and board of review comparable #3.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight suggested comparables for the Board's consideration. The Board finds the best evidence of assessment equity to be the appellant's comparables #3 and #4 as well as board of review comparables #1, #2, and #4 which are similar to the subject in location, design, age, and dwelling size with varying degrees of similarity in other features. Board of review comparable #4 lacks a garage, which is a feature of the subject, suggesting an upward adjustment for this difference would be necessary to make it more equivalent to the subject. These comparables have improvement assessments ranging from \$71,208 to \$97,830 or from \$25.52 to \$35.42 per square foot of living area. The subject's improvement assessment of \$95,992 or \$35.50 per square foot of living area falls within the range established by the best comparables in this record on an overall improvement assessment basis but slightly above on a per square foot basis. The Board gives less weight to the parties' remaining comparables which differ substantially from the subject in age/or dwelling size when compared to the subject. After considering appropriate adjustments to the best comparables for differences from the subject, the Board finds the subject's improvement is supported and a reduction is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
