



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Robert Berres

The parties of record before the Property Tax Appeal Board are Robert Berres, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook, and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$9,920
IMPR.: \$37,254
TOTAL: \$47,174

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame exterior construction with 1,774 square feet of living area. The dwelling was constructed in 1914 and is approximately 107 years old. Features of the home include a full unfinished basement, 1½ bathrooms, a fireplace and a two-car garage. The property has a 3,100 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 2-05 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity concerning the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located in the same neighborhood code as the subject. The comparables consist of class 2-05 dwellings of frame exterior construction that range in age from 108 to 123 years old. The homes range in size from 1,590 to 1,788 square feet of living area. Each comparable has a

full basement, 1 or 2 full bathrooms and three comparables have 1 or 2 half-baths. Features include central air conditioning and either a one-car or a two-car garage. Comparable #1 has a fireplace. The comparables have improvement assessments ranging from \$27,520 to \$33,520 or from \$16.57 to \$18.75 per square foot of living area.

Based on this evidence, the appellant requested a reduced improvement assessment of \$31,613 or \$17.82 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$47,174. The subject property has an improvement assessment of \$37,254 or \$21.00 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located in the same neighborhood code as the subject and either in the same tax block or within $\frac{1}{4}$ of a mile from the subject. The comparables consist of class 2-05 two-story dwellings of frame exterior construction that range in age from 110 to 120 years old. The homes range in size from 1,622 to 2,109 square feet of living area. Each comparable has a full or partial basement, two of which have finished area. Features include from 1 to 3 bathrooms and 1 half-bath and two comparables have either a one-car or a two-car garage. Two dwellings each have central air conditioning and one home has a fireplace. The comparables have improvement assessments ranging from \$38,928 to \$66,120 or from \$24.00 to \$31.35 per square foot of living area.

Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of eight equity comparables to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to appellant's comparable #2 and board of review comparable #1, each of which differ more significantly in dwelling size when compared to the subject and other comparables in the record.

The Board finds the best evidence of assessment equity to be appellant's comparables #1, #3 and #4 along with board of review comparables #2, #3 and #4, which are similar to the subject in location, design, and exterior construction, with adjustments necessary for age, dwelling size, bathroom count, finished basement area, fireplace and garage amenities to make these comparables more equivalent to the subject property. Each of these comparables necessitates upward adjustments for their inferior ages and/or inferior garage amenities when compared to the

subject's two-car garage. These six comparables have improvement assessments ranging from \$29,000 to \$43,422 or from \$16.57 to \$24.25 per square foot of living area. The subject's improvement assessment of \$37,254 or \$21.00 per square foot of living area falls within the range established by the best comparables in this record both in terms of overall improvement assessment and on a per-square-foot of living area basis. Based on this record and after considering appropriate adjustments to the best comparables for differences when compared to the subject property, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
