



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are George Polymenakos, the appellant, by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$8,435
IMPR.: \$21,144
TOTAL: \$29,579

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 3-story building of masonry exterior construction with 4,212 square feet of building area. The building is approximately 19 years old and features a concrete slab foundation. The property has a 3,749 square foot site and is located in Chicago, Hyde Park Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity concerning the improvement as the basis of the appeal. In support of this argument the appellant submitted information on nine equity comparables located within the same assessment neighborhood code as the subject. The comparables are improved with 3+-story, class 2-11 buildings of masonry exterior construction ranging in size from 4,230 to 5,202 square feet of building area. The buildings range in age from 102 to 112 years old. Each comparable has a basement, one of which has finished area. Seven

comparables each have three fireplaces and four comparables each have a 2-car garage. The comparables have improvement assessments ranging from \$10,875 to \$20,563 or from \$2.25 to \$4.09 per square foot of building area.

Based on this evidence the appellant requested a reduction in the subject's improvement assessment to \$13,067.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$29,579. The subject property has an improvement assessment of \$21,144 or \$5.02 per square foot of building area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables located within the same assessment neighborhood code as the subject. Comparable #1 is the same property as the appellant's comparable #7. The comparables are improved with 3-story, class 2-11 buildings of masonry exterior construction ranging in size from 4,068 to 4,992 square feet of building area. The buildings are 108 or 111 years old. Each comparable has a basement, one of which is finished with an apartment. One comparable has two fireplaces, and two comparables each have a 2-car garage. The comparables have improvement assessments ranging from \$13,562 to \$20,562 or from \$2.92 to \$4.83 per square foot of building area.

Based on this evidence the board of review requested the subject's assessment be sustained.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Adm.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Adm.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of thirteen equity comparables for the Board's consideration, all of which are substantially older buildings than the subject and each has a basement unlike the subject. Nonetheless, the Board gives less weight to the appellant's comparables #1 and #4 through #9 and the board of review's comparables #1, #3, and #4, including the common comparable, due to substantial differences from the subject in building size, basement finish, and/or garage amenity.

The Board finds the best evidence of assessment equity to be the appellant's comparables #2 and #3 and the board of review's comparable #2, which are more similar to the subject in building size, location, and features, although these comparables are much older buildings than the subject and each has a basement unlike the subject, suggesting adjustments to these comparables would be needed to make them more equivalent to the subject. These comparables have improvement assessments of \$14,562 and \$15,563 or from \$3.29 to \$3.68 per square foot of building area.

The subject's improvement assessment of \$21,144 or \$5.02 per square foot of building area falls above the range established by the best comparables in this record but appears to be supported after considering appropriate adjustments to the best comparables for differences from the subject. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
