



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board (PTAB) are Santo Bonafede, the appellant, by attorney Andreas Mamalakis, of the Law Offices of Andreas Mamalakis in Kenosha; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, PTAB hereby finds **No Change** in the Cook County Board of Review's assessment of the property is warranted. The correct assessed valuation of the property is:

LAND: \$7,444
IMPR.: \$20,758
TOTAL: \$28,202

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a Cook County Board of Review decision pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) contesting the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

A 1,214 square feet, one-story masonry structure on a 3,720 square feet lot in Chicago, Jefferson Township, Cook County comprises the subject property. The 56-year-old building, a class 2-03 property per the Cook County Real Property Assessment Classification Ordinance, featured 1.5 bathrooms, central air conditioning, a two-car garage, and a full basement.

Challenging the \$20,758 subject improvement assessment for inequity, the appellant argues the assessment rate should be lowered to \$8.63 per improvement square foot to achieve uniformity with like properties. To this end, the appellant put forth three class 2-03 properties within .49 miles of the subject with assessments between \$8.31 and \$9.09 per improvement square foot. The appellant's selections all had a one- or two-car garage, two fireplaces, one bathroom, and masonry construction. These suggested comparators ranged from 68 to 75 years in building age and from 1,166 to 1,314 square feet in living area.

The county board of review responded that the subject improvement was properly assessed at \$20,759, or \$17.10 per square foot, in its “Board of Review Notes on Appeal.” In defense of the \$28,202 total subject assessment, the county board of review introduced into evidence four one-story masonry buildings within a quarter mile of the subject as indicators of assessment equity. The board of review’s preferred comparators featured a two-car garage, one or 1.5 bathrooms, and a full basement. These properties also varied in building age from 60 to 70 years; in living square footage from 1,038 to 1,127; and in assessment from \$20.37 to \$20.85 per improvement square foot.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. The Illinois Constitution requires real estate taxes “be levied uniformly by valuation ascertained as the General Assembly shall provide by law.” Ill. Const., art. IX, § 4 (1970); Walsh v. Property Tax Appeal Board, 181 Ill. 2d 228, 234 (1998). Yet this uniformity provision of the Illinois Constitution does not require absolute equality in taxation; instead, a reasonable degree of uniformity in the taxing authority’s assessments suffices. Peacock v. Property Tax Appeal Board, 339 Ill. App. 3d 1060, 1070 (4th Dist. 2003).

When unequal treatment in the assessment is the basis of a property tax appeal, the appellant must prove the inequity of the assessments by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e); Walsh, 181 Ill. 2d at 234 (1998). Clear and convincing evidence means more than a preponderance of the evidence, but it does not need to approach the degree of proof needed for a criminal conviction. Bazyldo v. Volant, 164 Ill. 2d 207, 213 (1995). Proof of unequal treatment in the assessment process should comprise assessment documentation for the year in question of at least three comparable properties showing the similarity, proximity, and lack of distinguishing characteristics of the comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Property Tax Appeal Board (PTAB) finds the appellant did not surmount this burden of proof.

Of the parties’ submissions, board of review comparable #2 and appellant comparables #1 and #2 best resemble the subject improvement and therefore constitute the best evidence of assessment equity. Although it lacked some of the subject’s livable area and bathroom functionality, it did contain air conditioning. By contrast, appellant comparables #1 and #2 both featured more living space and two fireplaces, but lacked air conditioning and one of the subject’s half bathrooms. Moreover, both of the appellant comparables had inferior basements relative to the subject. Given this record, the subject improvement would be equitably assessed between \$8.31 to \$20.85 per living square foot. Because the subject improvement assessment of \$17.10 falls between these poles, PTAB concludes the appellant did not show assessment inequity by clear and convincing evidence and a reduction in the assessment is therefore not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
