

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Rodica Chis

The parties of record before the Property Tax Appeal Board (PTAB) are Rodica Chis, the appellant, by attorney Andreas Mamalakis, of the Law Offices of Andreas Mamalakis in Kenosha; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, PTAB hereby finds <u>No Change</u> in the Cook County Board of Review's assessment of the property is warranted. The correct assessed valuation of the property is:

**LAND:** \$7,440 **IMPR.:** \$22,420 **TOTAL:** \$29,860

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a Cook County Board of Review decision pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2021 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

### **Findings of Fact**

A 1,272 square feet, one-story masonry dwelling on a 3,720 square feet parcel in Chicago, Jefferson Township, Cook County comprises the subject property. The 49-year-old, class 2-03 property featured one bathroom and a full basement but lacked a fireplace, garage, and central air conditioning.

Contesting the equity of the \$22,420 subject improvement assessment, the appellant contends the assessment rate should be lowered to \$12.35 per improvement square foot to remain on par with those of similar properties. To this end, the appellant placed into evidence five class 2-03 properties within 1.09 miles of the subject with improvement assessments between \$11.53 and \$13.29 per living square foot. The appellant's suggested comparables featured at least one fireplace, one to two bathrooms, and zero to a two-car garage. These potential comparators varied from 59 to 68 years in building age and from 1,265 to 1,520 square feet in improvement size.

In response, the board of review countered that the subject improvement assessment of \$22,420, or \$17.63 per living square foot, was equitable in its "Notes on Appeal." To defend the \$29,860 total subject assessment, the county board of review put forth three masonry buildings on the subject's block as assessment benchmarks. The board of review's preferred comparators all featured a full basement, air conditioning, a two-car garage, and 1.5 bathrooms. These improvements were 48 or 49 years old; 1,176 or 1,272 square feet in living area; and \$20.09 or \$21.65 per living square foot in improvement assessment.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. The Illinois Constitution requires real estate taxes "be levied uniformly by valuation ascertained as the General Assembly shall provide by law." Ill. Const., art. IX, § 4 (1970); Walsh v. Property Tax Appeal Board, 181 Ill. 2d 228, 234 (1998). Yet this uniformity provision of the Illinois Constitution does not require absolute equality in taxation; instead, a reasonable degree of uniformity in the taxing authority's assessments suffices. Peacock v. Property Tax Appeal Board, 339 Ill. App. 3d 1060, 1070 (4th Dist. 2003).

When the ground for appeal is unequal treatment in the assessment, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e); Walsh, 181 Ill. 2d at 234 (1998). Clear and convincing evidence means more than a preponderance of the evidence, but it does not need to approach the degree of proof needed for a criminal conviction. Bazyldo v. Volant, 164 Ill. 2d 207, 213 (1995). Proof of unequal treatment in the assessment should consist of assessment documentation for the year in question of at least three comparable properties showing the similarity, proximity, and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Property Tax Appeal Board (PTAB) finds the appellant fell short of satisfying this burden of proof.

While the appellant submitted into evidence properties that were arguably comparable to the subject for the purposes of evaluating assessment uniformity, the board of review selected the properties most proximal and similar to the subject and that therefore circumscribe the range of equitable assessments for the subject. Board of review comparable #3 identically matched the subject improvement in all respects except in the inclusion of air conditioning, bathroom count, and a two-car garage. Meanwhile, although board of review comparables #1 and #2 lacked nearly one hundred square feet of the subject improvement's size, they featured an extra half bathroom, two-car garage, and air conditioning. Based on this record, the range of equitable assessments for the subject spans \$20.09 to \$21.65 per improvement square foot. Because the subject's \$17.63 per improvement square foot assessment falls below this range, PTAB concludes the appellant did not produce sufficiently clear and convincing evidence that the subject assessment was unconstitutionally nonuniform or that a reduction thereof is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE** 

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
