



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Paula & Peter Rogus, the appellants, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$41,710
IMPR.: \$186,040
TOTAL: \$227,750

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of brick exterior construction with 4,191 square feet of living area. The dwelling was constructed in 2000 and is approximately 22 years old. Features of the home include an unfinished walkout basement, central air conditioning, three fireplaces, and a garage with 759 square feet of building area. The property has an approximately 47,380 square foot site and is located in Hawthorn Woods, Ela Township, Lake County.

The appellants contend assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellants submitted information on four equity comparables located in the subject's assessment neighborhood code. The comparables are improved with 2-story dwellings of brick or wood siding exterior construction ranging in size from 3,692 to 4,096 square feet of living area. The dwellings range in age from 26 to 31 years

old. Each comparable has an unfinished basement, central air conditioning, one or two fireplaces, and a garage ranging in size from 709 to 958 square feet of building area. The comparables have improvement assessments ranging from \$125,605 to \$161,276 or from \$34.02 to \$39.52 per square foot of living area. Based on this evidence the appellants requested a reduction in the subject's improvement assessment to \$158,315 or \$37.77 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$227,750. The subject property has an improvement assessment of \$186,040 or \$44.39 per square foot of living area.

The board of review asserted that each of the board of review comparables are of the same house type as the subject

In support of its contention of the correct assessment, the board of review submitted information on five equity comparables located in the subject's assessment neighborhood code. The comparables are improved with 2-story dwellings of brick exterior construction ranging in size from 3,815 to 4,502 square feet of living area. The dwellings were built from 1997 to 2005. The comparables each have an unfinished basement, four of which are described as walkout style. Each comparable has central air conditioning, one or two fireplaces, and a garage ranging in size from 689 to 1,824 square feet of building area. The comparables have improvement assessments ranging from \$171,067 to \$212,767 or from \$44.23 to \$49.02 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellants contend assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine equity comparables for the Board's consideration. The Board gives less weight to the appellants' comparable #1 which differs from the subject in dwelling size.

The Board finds the best evidence of assessment equity to be the parties' eight remaining comparables which are similar to the subject in location, design, age, dwelling size, and features. The comparables have improvement assessments ranging from \$152,451 to \$212,767 or from \$38.65 to \$49.02 per square foot of living area. The subject's improvement assessment of \$186,040 or \$44.39 per square foot of living area falls within the range established by the best comparables in this record. Based on this record and after considering adjustments to the best comparables for differences from the subject, the Board finds the appellants did not demonstrate

with clear and convincing evidence that the subject's improvement is inequitably assessed and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
