



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Stephen Bennett

The parties of record before the Property Tax Appeal Board are Stephen Bennett, the appellant, by attorney Robert Rosenfeld of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$51,679
IMPR.: \$163,546
TOTAL: \$215,225

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of brick exterior construction with 3,470 square feet of living area. The dwelling was constructed in 1984, is approximately 38 years old and has a reported effective age of 1987. Features of the home include a basement, central air conditioning, a fireplace and a 693 square foot garage. The property has an approximately 62,050 square foot site and is located in Deer Park, Ela Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables that have the same assessment neighborhood code as the subject and are located from .7 of a mile to 2.5 miles from the subject property. The comparables are improved with two-story dwellings of brick or wood siding exterior construction ranging in size from 3,285 to 3,731 square feet of living area. The dwellings are 31 to 44 years old. Each comparable has a

basement, central air conditioning, a fireplace and a garage ranging in size from 529 to 851 square feet of building area. The comparables have improvement assessments ranging from \$126,084 to \$143,504 or from \$38.37 to \$39.58 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$134,375 or \$38.72 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$215,225. The subject property has an improvement assessment of \$163,546 or \$47.13 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on five equity comparables that have the same assessment neighborhood code as the subject and are located from .38 of a mile to 2.18 miles from the subject property. The comparables are improved with two-story dwellings of frame exterior construction ranging in size from 3,134 to 3,731 square feet of living area. The dwellings were built from 1987 to 1991 with comparable #5 having a reported effective age of 1992. Each comparable has a basement, central air conditioning, a fireplace and a garage ranging in size from 630 to 960 square feet of building area. Comparable #4 has an inground swimming pool. The comparables have improvement assessments ranging from \$126,806 to \$170,326 or from \$40.46 to \$49.57 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of nine suggested equity comparables for the Board's consideration. The Board has given less weight to the appellant's comparables #3 and #4, as well as board of review comparables #1, #4 and #5 due to their less proximate locations from the subject being approximately two miles or more away. Additionally, board of review comparable #4 has an inground swimming pool, when compared to the subject.

The Board finds the best evidence of assessment equity to be the appellant's comparables #1 and #2, along with board of review comparables #2 and #3, which have the same assessment neighborhood code as the subject, are located more proximate to the subject and are similar to the subject in design and some features. However, the Board finds the appellant's comparable dwellings are somewhat older in age and the appellant's comparable #2, along with the board of review's comparables are somewhat smaller in dwelling size, when compared to the subject, suggesting upward adjustments would be required to make the comparables more equivalent to the subject. Nevertheless, the comparables have improvement assessments that range from

\$126,084 to \$154,507 or from \$38.37 to \$48.43 per square foot of living area. The subject's improvement assessment of \$163,546 or \$47.13 per square foot of living area falls above the range established by the best comparables in the record in terms of overall improvement assessment but within the range on a per square foot basis. The subject's higher overall improvement assessment appears to be logical given its larger dwelling size and newer age. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
