

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Peter & Marcy Knysz DOCKET NO.: 22-00901.001-R-1 PARCEL NO.: 15-28-303-078

The parties of record before the Property Tax Appeal Board are Peter and Marcy Knysz, the appellants, by attorney Robert Rosenfeld of Robert H. Rosenfeld & Associates, LLC in Northbrook, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$29,495 **IMPR.:** \$122,549 **TOTAL:** \$152,044

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellants timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property is improved with two-story dwelling with wood siding exterior construction containing 2,266 square feet of living area. The dwelling was built in 1985 and is approximately 37 years old. Features of the home include a partial basement with 840 square feet of finished area, central air conditioning, one fireplace,  $2\frac{1}{2}$  bathrooms, and an attached two-car garage with 441 square feet of building area. The property has a 6,825 square foot site located in Buffalo Grove, Vernon Township, Lake County.

The appellants contend overvaluation as the basis of the appeal. In support of this argument the appellants submitted information on four comparable sales improved with two-story dwellings with wood siding exteriors that range in size from 2,460 to 2,814 square feet of living area. The homes range in age from 36 to 44 years old. Each property has a full or partial basement with finished area, central air conditioning,  $2\frac{1}{2}$  bathrooms, and an attached garage with either 420 or

462 square feet of building area. Two of the comparables have one fireplace. These properties have sites ranging in size from 8,908 to 11,451 square feet of land area. The comparables are in the same neighborhood as the subject and from approximately .29 to .51 of a mile from the subject property. The sales occurred from May to July 2021 for prices ranging from \$431,000 to \$524,900 or from \$170.41 to \$186.53 per square foot of living area, including land. The appellants requested the subject's total assessment be reduced to \$134,411.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$152,044. The subject's assessment reflects a market value of \$456,178 or \$201.31 per square foot of living area, land included, when using the statutory level of assessment of 33.33%.<sup>1</sup>

In support of its contention of the correct assessment the board of review submitted information on five comparable sales improved with two-story dwellings of frame construction that range in size from 2,155 to 2,266 square feet of living area. The homes were built from 1985 to 1987. Each comparable has a basement with three having finished area, central air conditioning,  $2\frac{1}{2}$  or  $3\frac{1}{2}$  bathrooms, and an attached garage with either 440 or 441 square feet of building area. Two of the comparables have one fireplace. These properties have sites ranging in size from 6,825 to 8,183 square feet of land area. The comparables are in the same neighborhood as the subject and from approximately .07 to .35 of a mile from the subject property. The sales occurred from May 2021 to January 2022 for prices ranging from \$452,500 to \$515,000 or from \$209.01 to \$235.27 per square foot of living area, including land.

## **Conclusion of Law**

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted information on nine comparable sales similar to the subject property in location and dwelling style, however, the Board finds the best evidence of market value to be comparable sales submitted by the board of review as these comparables are more similar to the subject in dwelling size and are overall more similar to the subject dwelling in age than are the comparables submitted by the appellants. These board of review comparables sold for prices ranging from \$452,500 to \$515,000 or from \$209.01 to \$235.27 per square foot of living area, including land. The subject's assessment reflects a market value of \$456,178 or \$201.31 per square foot of living area, including land, which is within the overall price range but below the range on a square foot of living area basis as established by the best comparable sales in this record. Based on this evidence the Board finds the assessment of the subject property is correct and a reduction in the subject's assessment is not justified.

<sup>&</sup>lt;sup>1</sup> Property Tax Appeal Board procedural rule section 1910.50(c)(1) provides that in all counties other than Cook, the three-year county wide assessment level as certified by the Illinois Department of Revenue (IDOR) will be considered. 86 Ill.Admin.Code Sec. 1910.50(c)(1). As of the development of this Final Administrative Decision, the IDOR has not published figures for tax year 2022.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
