

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Candy Thackston DOCKET NO.: 22-01860.001-R-1 PARCEL NO.: 09-02-304-039

The parties of record before the Property Tax Appeal Board are Candy Thackston, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Hawthorn Woods; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$15,621 **IMPR.:** \$79,912 **TOTAL:** \$95,533

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of vinyl siding exterior construction with 2,854 square feet of living area. The dwelling was built in 2013. Features of the home include an unfinished basement, central air conditioning, and a 506 square foot garage. The property has an approximately 6,730 square foot site and is located in Volo, Wauconda Township, Lake County.

The appellant contends assessment inequity with respect to the improvement assessment as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables that are located in the subject's assessment neighborhood code. The comparables are improved with 2-story dwellings ranging in size from 2,480 to 2,883 square feet of living area. The homes were built from 2007 to 2012. Each comparable is reported to have an unfinished basement, central air conditioning, and a garage with either 400 or 506 square feet

of building area. One comparable has one fireplace. The appellant reported the comparables have improvement assessments that range from \$68,526 to \$77,099 or from \$26.11 to \$27.63 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$75,545 or \$26.47 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$95,533. The subject property has an improvement assessment of \$79,912 or \$28.00 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables that are located in the subject's assessment neighborhood code. Board of review comparable #2 is the same property as the appellant's comparable #3¹. The comparables are improved with 2-story dwellings of vinyl siding or brick and vinyl siding exterior construction ranging in size from 2,854 to 2,883 square feet of living area. The homes were built from 2010 to 2013. The comparables each have a basement, one of which has finished area. Each comparable has central air conditioning and a garage with 506 square feet of building area. Two comparables each have one fireplace. The comparables have improvement assessments that range from \$81,594 to \$83,524 or from \$28.30 to \$29.27 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments, for the assessment year in question, of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted seven equity comparables for the Board's consideration, as one property was common to both parties. The Board gives less weight to the appellant's comparable #2 which differs from the subject in dwelling size. The Board also gives less weight to board of review comparable #4 which has basement finish, unlike the subject.

The Board finds the best evidence of assessment equity to be parties' five remaining comparables which are similar to the subject in location, age, design, dwelling size, and other features. These most similar comparables have improvement assessments that range from \$74,519 to \$82,922 or from \$26.11 to \$29.05 per square foot of living area. The subject's improvement assessment of \$79,912 or \$28.00 per square foot of living area falls within the range established by the best comparables in this record. Furthermore, the discrepancy in assessment amounts for the parties' common comparable calls into question the tax year assessment reported in the appellant's grid. Based on this record and after considering

appropriate adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
