



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Renee L. Broaddus, the appellant, by Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$32,512  
**IMPR.:** \$102,060  
**TOTAL:** \$134,572

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a split-level dwelling of frame exterior construction with 1,620 square feet of above ground living area. The dwelling was constructed in 1963. Features of the home include an unfinished basement, a lower level with finished area, central air conditioning, a fireplace, and a 484 square foot garage. The property has a 13,406 square foot site and is located in Barrington, Ela Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on eight equity comparables located within the same assessment neighborhood code as the subject. The comparables are described as split-level dwellings of brick, frame, or brick and frame exterior construction ranging in size from 1,616 to 1,765 square feet of above ground living area. The dwellings were built from 1955 to 1971 and have basements/lower levels with finished area. Six

comparables each have one or two fireplaces. Seven comparables have central air conditioning and each comparable has a garage ranging in size from 440 to 540 square feet of building area. The comparables have improvement assessments ranging from \$88,939 to \$105,102 or from \$50.76 to \$59.55 per square foot of above ground living area. Based on this evidence the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$137,767. The subject property has an improvement assessment of \$105,255 or \$64.97 per square foot of above ground living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables located within the same assessment neighborhood code as the subject. The comparables are described as 2-story dwellings of brick exterior construction ranging in size from 1,410 to 1,604 square feet of above ground living area. The dwellings were built in 1961 and have unfinished basements. Each comparable has a lower level with finished area, central air conditioning, a fireplace and a garage ranging in size from 440 to 484 square feet of building area. The comparables have improvement assessments ranging from \$91,437 to \$101,698 or from \$62.79 to \$65.53 per square foot of above ground living area. Based on this evidence, the board of review requests no change to the subject's assessment.

In rebuttal, the appellant's counsel contends board of review comparables #3 and #4 are not comparable to the subject due to differences in size.

### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted 12 equity comparables for the Board's consideration. The Board gives less weight to appellant's comparables #1, #2, #6, and #8 as well as board of review comparables #3 and #4 which are less similar to the subject in dwelling size.

The Board finds the best evidence of assessment equity to be appellant's comparables #2, #3, #4, and #7 as well as board of review comparables #1 and #2 which are most similar to the subject in dwelling size and similar in location, age and most features. These comparables have improvement assessments that range from \$90,775 to \$101,698 or from \$54.03 to \$63.40 per square foot of above ground living area. The subject's improvement assessment of \$105,255 or \$64.97 per square foot of above ground living area falls above the range established by the best comparables in this record. Therefore, after considering appropriate adjustments to the comparables for differences from the subject, the Board finds the appellant demonstrated with

clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
