



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Teresa Grosch & Thomas Roberts

The parties of record before the Property Tax Appeal Board are Teresa Grosch & Thomas Roberts, the appellants, by attorney Anthony M. Farace, of Amari & Locallo in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$17,625
IMPR.: \$57,375
TOTAL: \$75,000

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of stucco exterior construction with 2,484 square feet of living area. The dwelling is 94 years old. Features of the home include a basement and a fireplace. The property has a 7,050 square foot site and is located in Glencoe, New Trier Township, Cook County. The subject is classified as a class 2-06 property under the Cook County Real Property Assessment Classification Ordinance.

The appellants contend assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellants submitted information on five equity comparables located within the subject's assessment neighborhood and within .8 of a mile of the subject. The comparables consist of 2-story class 2-06 dwellings of stucco, masonry, or frame and masonry exterior construction ranging in size from 2,344 to 2,907 square feet of living area. The homes range in age from 79 to 100 years old. One dwelling has central air conditioning and

each home has a fireplace and a 1.5-car or 2-car garage. The comparables have improvement assessments ranging from \$15,160 to \$49,500 or from \$6.23 to \$19.90 per square foot of living area. Based on this evidence, the appellants requested a reduced improvement assessment of \$30,215 or \$12.16 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$75,000. The subject property has an improvement assessment of \$57,375 or \$23.10 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables located within the subject's assessment neighborhood and within .25 of a mile of the subject. The comparables consist of 2-story class 2-06 dwellings of masonry exterior construction ranging in size from 2,344 to 2,897 square feet of living area. The homes range from 92 to 106 years old. Each dwelling has a fireplace and a full or partial basement, one of which has finished area. One comparable has central air conditioning and three comparables each have a 1-car, 1.5-car, or 2-car garage. The comparables have improvement assessments ranging from \$60,000 to \$72,967 or from \$25.19 to \$30.02 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayers contend assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill. Admin. Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity, and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill. Admin. Code §1910.65(b). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine equity comparables to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to the comparables submitted by the appellants, each of which reportedly lacks a basement foundation, a feature of the subject. Further, the appellants' comparables #1, #3, and #4 differ from the subject in age, dwelling size, or feature central air conditioning unlike the subject. The Board also gives less weight to board of review comparable #1, which differs from the subject in dwelling size and features central air conditioning unlike the subject.

The Board finds the best evidence of assessment equity to be the board of review's comparables #2, #3, and #4, which are similar to the subject in age, location, foundation, dwelling size, and some features. These comparables have improvement assessments that range from \$60,000 to \$71,250 or from \$25.30 to \$30.02 per square foot of living area. The subject's improvement assessment of \$57,375 or \$23.10 per square foot of living area falls below the range established by the best comparables in this record. Based on this record and after considering adjustments to the best comparables for differences from the subject, the Board finds the appellants did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
