



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Hannah Graham, the appellant, by attorney Brian S. Maher, of Weis, DuBrock, Doody & Maher in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$7,800
IMPR.: \$28,041
TOTAL: \$35,841

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of frame and masonry exterior construction with 1,486 square feet of living area. The dwelling is approximately 93 years old. Features of the home include a full unfinished basement, one fireplace and a 2-car garage. The property has an approximately 7,800 square foot site and is located in Mount Prospect, Elk Grove Township, Cook County. The subject is classified as a class 2-05 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables that are located in the same assessment neighborhood code as the subject property. The comparables are improved with class 2-05, 2-story dwellings of masonry, frame or frame and masonry exterior construction that range in size from 1,738 to 1,915 square feet of living area. The dwellings range in age from 92 to 97 years old. Each comparable has a full basement. The comparables each have a 1-car garage. One comparable has central air conditioning and

three comparables each have either one or two fireplaces. The comparables have improvement assessments that range from \$27,485 to \$30,200 or from \$15.25 to \$16.72 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$23,523 or \$15.83 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$35,841. The subject property has an improvement assessment of \$28,041 or \$18.87 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located in the same assessment neighborhood code as the subject property. The comparables are improved with class 2-05, 2-story dwellings of frame and masonry exterior construction that range in size from 1,260 to 1,486 square feet of living area. The dwellings range in age from 71 to 95 years old. Each comparable has a full basement, three finished with a recreation room. Two comparables each have central air conditioning and three comparables each have either one or two fireplaces. The comparables each have either a 1-car or a 2-car garage. The comparables have improvement assessments ranging from \$28,750 to \$30,580 or from \$20.32 to \$24.22 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight suggested equity comparables for the Board's consideration. The Board has given less weight to appellant's comparable #3 as well as board of review comparables #2 and #3 due to their differences from the subject in age or central air conditioning amenity. The Board finds the best evidence of assessment equity to be appellant's comparables #1, #2 and #4 along with board of review comparables #1 and #4. The Board finds that these comparables are most similar to the subject in location, design, dwelling size, age, and some features. These most similar comparables have improvement assessments ranging from \$29,200 to \$30,580 or from \$15.25 to \$21.00 per square foot of living area. The subject's improvement assessment of \$28,041 or \$18.87 per square foot of living area, falls within the range of the best comparables in this record on a square foot basis but below the range on an overall improvement basis. Based on this record and after considering adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
