



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: James & Jillian Maruna

The parties of record before the Property Tax Appeal Board are James & Jillian Maruna, the appellants, by attorney Andrew Frankenthal of Field and Goldberg, LLC, in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 7,240
IMPR.: \$65,010
TOTAL: \$72,250

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the Property Tax Appeal Board pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a single-family owner-occupied residence located in West Chicago Township, Cook County.

The appellants contend the subject property's assessment is not reflective of market value. In support of this argument, the appellants submitted evidence that the subject property sold in May 2020 for \$722,500. Based on this evidence, the appellants requested a reduction in the subject's assessment.

The board of review of review submitted its board of review "Notes on Appeal" disclosing the subject's final assessment of \$89,148. The board of review submitted a condominium sales analysis to support its assessment of the subject property. Based on this evidence, the board of review requested confirmation of the subject's assessment.

By postmark date of July 14, 2025, the appellants filed a Motion to Enforce the Rollover Statute as provided by Section 16-185 of the Property Tax Code (35 ILCS 200/16-185) with Proof of Service to the Cook County Board of Review. The motion asserts the decision by the Property Tax Appeal Board for the 2021 tax year should be carried forward to the 2022 tax year pursuant to section 16-185 of the Property Tax Code. (35 ILCS 200/16-185). The appellants argued the subject property is an owner-occupied residence that was the subject matter of an appeal before the Property Tax Appeal Board the prior year under Docket Number 21-33874.001-R-1. In that appeal the Property Tax Appeal Board issued a decision lowering the assessment of the subject property to \$72,750. The appellants asserted that the subject property is an owner-occupied dwelling and tax years 2021 and 2022 are within the same general assessment period for West Chicago Township.

The board of review did not file a response to the Motion to Enforce the Rollover Statute by the established deadline of August 13, 2025. (86 Ill.Admin.Code §1910.64(d)).

Conclusion of Law

The appellants filed a Motion to Enforce the Rollover Statute pursuant to Section 16-185 of the Property Tax Code. (35 ILCS 200/16-185). The Property Tax Appeal Board Hereby **Grants** the Motion to Enforce the Rollover Statute. The Property Tax Appeal Board finds that the assessment as established by the Board for the 2021 tax year shall be carried forward to the 2022 tax year subject only to equalization as provided by section 16-185 of the Property Tax Code.

Section 16-185 of the Property Tax Code (35 ILCS 200/16-185) states in part:

If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel on which a residence occupied by the owner is situated, such reduced assessment, subject to equalization, shall remain in effect for the remainder of the general assessment period as provided in Sections 9-215 through 9-225, unless that parcel is subsequently sold in an arm's length transaction establishing a fair cash value for the parcel that is different from the fair cash value on which the Board's assessment is based, or unless the decision of the Property Tax Appeal Board is reversed or modified upon review.

The record disclosed the Property Tax Appeal Board issued a decision reducing the subject's assessment for the 2021 tax year. The record further indicates that the subject property is an owner-occupied dwelling and that the 2021 and 2022 tax years are within the same general assessment period. The record contains no evidence indicating the subject property sold in an arm's length transaction subsequent to the Board's decision or that the decision of the Property Tax Appeal Board has been reversed or modified upon review. For these reasons the Property Tax Appeal Board finds that a reduction in the subject's assessment is warranted to reflect the assessment as established in the Board's prior year's decision plus the application of an equalization, if any.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
