



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Larry Gies

The parties of record before the Property Tax Appeal Board are Larry Gies, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$27,900
IMPR.: \$73,721
TOTAL: \$101,621

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with a two-story dwelling of masonry exterior construction with 2,478 square feet of living area. The dwelling is approximately 16 years old. Features include a full basement with finished area, 2½ bathrooms, central air conditioning, one fireplace, and a two-car garage. The property has a 3,100 square foot site and is located in Chicago, Lake View Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity concerning the improvement as the basis of the appeal. In support of the argument, the appellant submitted information on four comparables located in the same neighborhood code as the subject and within .6 of a mile from the subject. The comparables consist of class 2-78 two-story dwellings of masonry exterior construction ranging in size from 2,304 to 2,792 square feet of living area. The homes range in age from 15

to 29 years old. Each comparable has a full basement, 2½ or 3½ bathrooms, central air conditioning, and two-car garages. Three homes each have one or three fireplaces. The comparables have improvement assessments ranging from \$65,000 to \$79,460 or from \$24.64 to \$28.98 per square foot of living area.

Based on this evidence the appellant requested the subject's improvement assessment be reduced to \$68,318 or \$27.57 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$101,621. The subject property has an improvement assessment of \$73,721 or \$29.75 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located within the same neighborhood code and either the same block or within ¼ of a mile from the subject. The comparables are improved with class 2-78 two-story dwellings of masonry exterior construction that range in size from 2,484 to 2,820 square feet of living area. The comparables range in age from 7 to 16 years old. Features include full basements with finished area, 2½ or 3½ bathrooms, central air conditioning, and either a 2-car or a 2.5-car garage. Three homes each have one or three fireplaces. The comparables have improvement assessments ranging from \$80,325 to \$95,875 or from \$31.87 to \$34.00 per square foot of living area.

Based on this evidence, the board of review requested that the subject's assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of eight suggested equity comparables to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to the appellant's comparables #1 and #2 along with board of review comparable #2, due significant differences in age, when compared to the subject. The Board has given reduced weight to the appellant's comparable #3 along with board of review comparable #4, due significant differences in dwelling size, when compared to the subject.

The Board finds the best evidence of assessment equity to be appellant's comparable #4 as well as board of review comparables #1 and #3, which are each more similar to the subject in location, design, foundation, air conditioning and garage amenity. Adjustments to these comparables are necessary for differences when compared to the subject such as age, bathroom

count and/or fireplace count in order to make them more equivalent to the subject. The best comparables have improvement assessment ranging from \$74,179 to \$85,100 or from \$28.98 to \$32.34 per square foot of living area. The subject's improvement assessment of \$73,721 or \$29.75 per square foot of living area falls below the range established by the best comparables in this record in terms of overall improvement assessment and within the range on a per-square-foot of living area basis.

Based on this record and after considering appropriate adjustments to the best comparables for differences in comparison to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
