

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Gaspare Vitale, the appellant(s), by attorney Dora Cornelio, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

# **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a an approximately 28-year-old two-story dwelling of masonry construction with 3,445 square feet of living area. Features of the home include two bathrooms and a two-car garage. The property has a 9,375 square foot site and is located in Park Ridge, Maine Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables. In its filing, the appellant only filled out information for four comparables in the Section V grid. In an attached brief, a fifth property is referred to as "Comp. 2", but this property has the same PIN (09-25-315-031-0000) as the subject property and otherwise has the same building area as the subject property. This comparable was therefore not considered and the other four comparables were

evaluated. The four comparables have the same neighborhood code as the appellant's property, but the appellant did not identify the proximity of these properties to the subject property. These are class 2-78 two story residences, with masonry, frame, or frame and masonry construction, are between one and 58 years old, have full basements or a slab foundation, have central air conditioning, have zero to two fireplaces, have a two car garage, contain between 3,138 and 3,628 square feet of living area, and have improvement assessments between \$11.06 and \$13.31 per square foot. The appellant is requesting a total assessment of \$52,631.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$76,933 (per the attached Board of review decision letter). The subject property has an improvement assessment of \$64,746 or \$18.79 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on three equity comparables. These comparables have the same neighborhood code as the subject property and are located 0.25 miles away. These comparables are two-story residences with masonry or frame construction, are between 11 and 18 years old, have full basements, two comparables have central air conditioning while one does not, the comparables have zero to one fireplace, have between a one-car and a three car garage, have between 2,580 and 2,775 square feet of living area, and have improvement assessments between \$22.19 and \$24.45 per square foot.

# **Conclusion of Law**

The taxpayer asserts assessment inequity as the basis of the appeal. The Illinois Constitution requires that real estate taxes, "be levied uniformly by valuation ascertained as the General Assembly shall provide by law." Ill. Const. art. IX, §4 (1970); Walsh v. Property Tax Appeal Board, 181 Ill. 2d 228, 234 (1998). This uniformity provision of the Illinois Constitution does not require absolute equality in taxation, however, and it is sufficient if the taxing authority achieves a reasonable degree of uniformity. Peacock v. Property Tax Appeal Board, 339 Ill. App. 3d 1060, 1070 (4<sup>th</sup> Dist. 2003).

When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e); Walsh, 181 Ill. 2d at 234 (1998). Clear and convincing evidence means more than a preponderance of the evidence, but it does not need to approach the degree of proof needed for a conviction of a crime. Bazyldo v. Volant, 164 Ill. 2d 207, 213 (1995). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be appellant's comparable #4 and board of review's comparables #1 and #2. As for comparables not found to be best evidence, comparable three is much smaller than appellant's property, has a finished basement, has central air conditioning, has a larger garage, only has 1.5 bathrooms, and has different exterior construction. As for appellant's comparables #1, #2, and #3, they are all farther away from the subject property compared to the other comparables. Further, appellant's comparable #1 has a

finished basement, more bathrooms, two fireplaces, and central air conditioning. In addition, appellant's comparable #2 has a slab foundation as opposed to a basement, another bathroom, a higher property age, and central air conditioning. Also, appellant's comparable #3 is a new property, has three more bathrooms, a finished basement, a fireplace, and central air conditioning when compared to the subject property. The best comparables had improvement assessments that ranged from \$13.31 to \$23.05 per square foot of living area. The subject's improvement assessment of \$18.79 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
