



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Azim Hemani, the appellant, by attorney Brian P. Liston, of the Law Offices of Liston & Tsantilis, P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$11,438
IMPR.: \$90,561
TOTAL: \$101,999

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of frame exterior construction with 4,296 square feet of living area. The dwelling is approximately 16 years old. Features of the home include a full basement with finished area, central air conditioning, a fireplace and a 2-car garage. The property has a 10,894 square foot site and is located in Glenview, Maine Township, Cook County. The subject is classified as a class 2-08 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on three equity comparables located within the same assessment neighborhood code as the subject and within .60 of a mile from the subject. The comparables consist of class 2-08 dwellings of masonry or frame and masonry exterior construction ranging in size from 3,952 to 4,600 square feet of living

area. The dwellings are 15 to 34 years old. The appellant reported the comparables have full basements and “N/A” for the finished basement area. Each comparable has central air conditioning, 1 or 2 fireplaces and a 2-car or a 2½-car garage. The comparables have improvement assessments ranging from \$68,288 to \$77,707 or from \$14.85 to \$18.00 per square foot of living area.

Based on this evidence, the appellant requested that the improvement assessment be reduced to \$72,187 or \$16.80 per square foot of living area.

The board of review submitted its “Board of Review Notes on Appeal.” The appellant submitted a copy of the Cook County Board of Review final decision for the 2022 tax year disclosing the total assessment for the subject property of \$101,999. The subject property has an improvement assessment of \$90,561 or \$21.08 per square foot of building area.

In support of its contention of the correct assessment, the board of review submitted information on two equity comparables located within the same assessment neighborhood code and subarea as the subject. The comparables consist of class 2-08, 2-story dwellings of masonry or frame exterior construction of 3,831 or 4,260 square feet of living area. The comparables are 4 or 22 years old. Each comparable has a full basement with finished area, central air conditioning, 1 or 3 fireplaces and a 2-car or a 3½-car garage. The comparables have improvement assessments of \$80,451 and \$100,124 or \$21.00 and \$23.50 per square foot of living area.

Based on this evidence, the board of review requested the assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted five equity comparables for the Board's consideration. The Board gives less weight to the appellant's comparables #1 and #2 as well as the board of review comparable #2 which differ substantially from the subject in age.

The Board finds the best evidence of assessment equity to be the appellant's comparable #3 and board of review comparable #1. These comparables are relatively similar to the subject in location, dwelling size, age and some features. In addition, the appellant's comparable may require an upward adjustment for lack of a basement finish, which is a feature of the subject, given the appellant did not disclose whether their comparables have a finished or unfinished basement area. These two comparables have improvement assessments of \$77,707 and \$100,124 or \$18.00 and \$23.50 per square foot of living area, respectively. The subject's improvement assessment of \$90,561 or \$21.08 per square foot of living area is bracketed by the two best

comparables in the record. After considering the adjustments to the two best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
