

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Mary Kay Marquisos DOCKET NO.: 22-46214.001-R-1 PARCEL NO.: 13-04-208-002-0000

The parties of record before the Property Tax Appeal Board are Mary Kay Marquisos, the appellant, by attorney Andrew S. Dziuk, of Andrew Dziuk, Esq. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$10,938 **IMPR.:** \$47,800 **TOTAL:** \$58,738

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 2-story dwelling of masonry exterior construction with 2,746 square feet of living area and is approximately 74 years old. Features include a full basement, central air conditioning, one fireplace, and a 2-car garage. The property has a 4,375 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 2-06 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five equity comparables with the same assessment neighborhood code as the subject property. The comparables are improved with class 2-06 dwellings of masonry exterior construction ranging in size from 2,202 to 3,106 square feet of living area. The homes range in age from 70 to 82 years old. Four comparables each have a full basement and one comparable has a slab foundation.

One comparable has two fireplaces. Each comparable has a 1-car or a 2-car garage. The comparables have improvement assessments ranging from \$32,678 to \$37,738 or from \$12.15 to \$15.44 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$58,738. The subject property has an improvement assessment of \$47,800 or \$17.41 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables with the same assessment neighborhood code as the subject property. The comparables are improved with 2-story, class 2-05 or class 2-06 dwellings of masonry exterior construction ranging in size from 1,645 to 2,681 square feet of living area. The homes range in age from 74 to 80 years old. The comparables each have a full or partial basement and central air conditioning. Three comparables each have one or two fireplaces. Three comparables each have a 1-car or a 2-car garage. The comparables have improvement assessments ranging from \$37,045 to \$54,063 or from \$19.78 to \$22.52 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

# **Conclusion of Law**

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted nine suggested comparables for the Board's consideration. The Board gives less weight to the appellant's comparables as well as board of review comparables #1 and #4 which lack central air conditioning, which is a feature of the subject, and/or due to substantial differences from the subject in dwelling size. Further, the appellant's comparable #1 differs from the subject in foundation type and board of review comparable #4 lacks a garage amenity, which the subject features.

The Board finds the best evidence of assessment equity to be board of review comparables #2 and #3 which are more similar to the subject in location, design/class, age, and dwelling size with varying degrees of similarity in other features. The comparables have improvement assessments of \$51,595 and \$54,063 or \$20.17 and \$20.56 per square foot of living area. The subject's improvement assessment of \$47,800 or \$17.41 per square foot of living area falls below the two best comparables in this record. Based on this record and after considering adjustments to the two best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

The Property Tax Appeal Board does not require any motion or request for reconsideration.

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
