

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Katarzyna Sarnecki DOCKET NO.: 22-46441.001-R-1 PARCEL NO.: 13-17-107-115-0000

The parties of record before the Property Tax Appeal Board are Katarzyna Sarnecki, the appellant, by attorney Andrew S. Dziuk, of Andrew Dziuk, Esq. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$14,000 **IMPR.:** \$23,000 **TOTAL:** \$37,000

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story, multi-family building of frame and masonry exterior construction with 2,266 square feet of gross building area and is approximately 59 years old. Features include a full basement, 2.5 bathrooms, and a 1.5-car garage. The property has a 5,000 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables with the same assessment neighborhood code as the subject. The comparables are improved with class 2-11 multi-family buildings of frame and masonry exterior construction ranging in size from 1,983 to 2,412 square feet of gross building area. The buildings range in

age from 63 to 98 years old. Each comparable has a full basement, either 2.0 or 3.0 bathrooms, and either a 1-car or a 2-car garage. The comparables have improvement assessments ranging from \$17,034 to \$24,361 or from \$8.50 to \$10.10 per square foot of gross building area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$37,000. The subject property has an improvement assessment of \$23,000 or \$10.15 per square foot of gross building area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables with the same assessment neighborhood code as the subject. The comparables are improved with 2-story, class 2-11 multi-family buildings of frame and masonry exterior construction ranging in size from 2,106 to 2,466 square feet of gross building area. The buildings range in age from 58 to 60 years old. Each comparable has a full basement with two of these having finished area, 2.0 bathrooms, and either a 2-car or a 2.5-car garage. One comparable has central air conditioning. The comparables have improvement assessments ranging from \$21,648 to \$29,234 or from \$10.28 to \$13.15 per square foot of gross building area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight suggested comparables for the Board's consideration. The Board gives less weight to the appellant's comparables #1, #2, and #3 due to substantial differences from the subject in age. The Board also gives less weight to board of review comparables #2 and #4 which feature basement finish, unlike the subject.

The Board finds the best evidence of assessment equity to be the appellant's comparable #4 as well as board of review comparables #1 and #3 which are overall more similar to the subject in class, age, gross building size, and most features. These comparables have improvement assessments ranging from \$21,648 to \$29,234 or from \$10.10 to \$13.15 per square foot of gross building area. The subject's improvement assessment of \$23,000 or \$10.15 per square foot of gross building area falls within the range established by the best comparables in this record. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

The Property Tax Appeal Board does not require any motion or request for reconsideration.

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
