



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Jan Boloz, the appellant, by attorney Andrew S. Dziuk, of Andrew Dziuk, Esq. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$10,937
IMPR.: \$17,718
TOTAL: \$28,655

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 1-story dwelling of frame exterior construction with 2,444 square feet of living area and is approximately 114 years old. Features include a slab foundation, 2.0 bathrooms, and a 2-car garage. The property has a 3,906 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 2-04 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five equity comparables with the same assessment neighborhood code as the subject. The comparables are improved with class 2-04 dwellings of frame exterior construction ranging in size from 1,980 to 2,157 square feet of living area. The homes range in age from 96 to 111 years old. Each comparable has a full basement and from 1.0 to 2.5 bathrooms. Four comparables have from a

1-car to a 2-car garage. The comparables have improvement assessments ranging from \$12,435 to \$14,683 or from \$6.28 to \$6.81 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$28,656. The subject property has an improvement assessment of \$17,719 or \$7.25 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables with the same assessment neighborhood code as the subject. The comparables are improved with 1-story or 1.5-story, class 2-04 dwellings of frame exterior construction ranging in size from 1,824 to 1,931 square feet of living area. The homes range in age from 63 to 111 years old. Three comparables each have a full basement and one comparable has a slab foundation. Each comparable has either 1.0 or 2.0 bathrooms. One comparable has central air conditioning. Two comparables each have a 2-car garage. The comparables have improvement assessments ranging from \$14,626 to \$16,749 or from \$7.57 to \$9.18 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted nine suggested comparables for the Board's consideration. The Board finds each of these comparables is located in the subject's neighborhood code with varying degrees of similarity to the subject in property characteristics. Each of the parties' comparables presents two or more significant differences from the subject in property characteristics. Each comparable is a substantially smaller dwelling than the subject and eight comparables feature a basement foundation, which the subject lacks. The forgoing differences, in addition to others, would require appropriate adjustments for these differences to make them more equivalent to the subject. Nevertheless, the parties' comparables have improvement assessments ranging from \$12,435 to \$16,749 or from \$6.28 to \$9.18 per square foot of living area. The subject's improvement assessment of \$17,719 or \$7.25 per square foot of living area falls above the range established by the comparables in this record on an overall basis but within the range on a per square foot basis. The subject's higher overall improvement assessment is logical considering its larger dwelling size and/or garage capacity when compared to the comparables in this record. After considering the disparate sets of evidence submitted by the parties, the Board finds the evidence in this record does not support a reduction in the subject's assessment.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
