



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Craig Jorgenson, the appellant(s), by attorney Richard Shapiro, Attorney at Law in Evanston; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$19,579
IMPR.: \$25,921
TOTAL: \$45,500

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of an approximately 67-year-old one-story dwelling of masonry construction with 2,677 square feet of living area. Features of the home include a slab foundation, central air conditioning, two fireplaces and a two-car garage. The property has a 19,579 square foot site and is located in Mount Prospect, Wheeling Township, Cook County. The property is a class 2-04 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted an appraisal estimating the subject property had a market value of \$455,000 as of December 31, 2020. The appraiser relied on a sales comparison approach and identified five comparable properties. These properties are located 0.11 to 0.95 miles away from the subject property. The properties sold between May 2020 to July 2020 for sale prices between

\$392,000 and \$525,000. The properties have between 2,121 and 2,747 square feet of living area and have unit sale prices per square foot between \$176.97 and \$204.61. In the appraisal, the appraiser adjusted sale prices based on factors such as condition, room numbers, basement, site area, and living area square footage. The appellant is requesting a total assessment of \$45,500.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$51,000. The subject's assessment reflects a market value of \$41,421 or \$11.74 per square foot of living area, including land. In support of its contention of the correct assessment the board of review submitted information on four comparable sales. The board of review identified four comparable. Comparables #1 and #2 are located 0.25 miles from or within the same "subarea" as the subject property. The board of review did not state the distance of comparables #3 and #4 from the subject property. The unadjusted sales occurred from May 2019 to March 2022 for sales prices between \$435,000 and \$675,000. The sales price per square foot are between \$186.92 and \$294.76. The board of review is requesting that the current assessment be confirmed.

Conclusion of Law

The appellant contends that the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal, the value of the property must be proved by a preponderance of the evidence. 86 Ill. Admin. Code §1910.63(e); Winnebago County Bd. of Review v. Property Tax Appeal Bd., 313 Ill. App. 3d 1038, 1043 (2d Dist. 2000). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales, or construction costs. 86 Ill. Admin. Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds that the best evidence of the subject's market value is the appraisal submitted by the appellant. That appraisal employed the sales comparison approach, relying upon sales of five suggested comparable properties in Mount Prospect between May 2020 to July 2020, for amounts ranging from \$392,000 and \$525,000, or from \$176.97 and \$204.61 per square foot of living area, land included in the sales prices. The appraiser adjusted these sales prices to account for differences between the subject and the comparables. In contrast, the board of review's evidence consists of unadjusted data from several sales.

Accordingly, the Board finds the subject property had a fair market value of \$455,000 as of the assessment date at issue. Because the assessment reflects a greater fair market value, the Board finds a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
