



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are George Kokkinias, the appellant, by attorney Andreas Mamalakis, of the Law Offices of Andreas Mamalakis in Kenosha; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$4,981
IMPR.: \$46,018
TOTAL: \$50,999

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story multi-family building of masonry exterior construction with 3,558 square feet of gross building area. The building is approximately 93 years old. The building features a full basement finished with an apartment, three full bathrooms, one half bathroom, and a 2-car garage. The property has a 3,690 square foot site and is located in Skokie, Niles Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five equity comparables located within the subject's assessment neighborhood and from 0.07 to 0.91 of a mile from the subject property. The comparables are improved with 2-story or 3-story, class 2-11 multi-family buildings of masonry exterior construction ranging in size from 3,780 to 4,032

square feet of gross building area. The buildings range in age from 90 to 96 years old. Each comparable has a full basement, two or three bathrooms, and two fireplaces. Comparable #5 has two additional half bathrooms and central air conditioning. Four comparables each have a 2-car garage. The comparables have improvement assessments ranging from \$45,482 to \$49,019 or from \$11.40 to \$12.76 per square foot of gross building area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced.

The board of review submitted its "Board of Review Notes on Appeal." The appellant submitted the board of review final decision disclosing the total assessment for the subject of \$50,999. The subject property has an improvement assessment of \$46,018 or \$12.93 per square foot of gross building area. In support of its contention of the correct assessment, the board of review submitted information on three equity comparables located within the subject's assessment neighborhood, as well as on the same block and along the same street as the subject property. The comparables are improved with 2-story, class 2-11 multi-family buildings of masonry exterior construction with either 2,688 or 2,744 square feet of gross building area. The buildings are either 94 or 95 years old. Each comparable has a full basement, two full bathrooms, and a 2-car garage. The comparables have improvement assessments ranging from \$39,019 to \$39,899 or from \$14.52 to \$14.69 per square foot of gross building area.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight suggested equity comparables for the Board's consideration. The Board gives less weight to the appellant's comparables due to differences when compared to the subject in design, central air conditioning, and/or garage amenity.

The Board finds the best evidence of assessment equity to be the board of review comparables which are overall more similar to the subject in location, design/class, and age with varying degrees of similarity in bathroom count, gross building size, and other features. The best comparables have improvement assessments ranging from \$39,019 to \$39,899 or from \$14.52 to \$14.69 per square foot of gross building area. The subject's improvement assessment of \$46,018 or \$12.93 per square foot of gross building area falls above the range established by the best comparables in this record on an overall improvement assessment basis and below the range on a per square foot basis. The subject's higher improvement assessment is logical when considering both its larger size and greater bathroom count when compared to the best comparables. After considering the necessary adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
