



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Jay Beadle, the appellant, by attorney Abby L. Strauss, of Schiller Law P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$19,699
IMPR.: \$56,798
TOTAL: \$76,497

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 1-story dwelling of masonry exterior construction with 2,271 square feet of living area. The dwelling is approximately 63 years old. Features of the home include a full basement with finished area,¹ central air conditioning, 3 fireplaces and a 2-car garage. The board of review indicated the subject has other improvements that were not described. The property has a 16,416 square foot site and is located in Glenview, Niles Township, Cook County. The subject is classified as a class 2-04 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five comparables located within the subject's assessment neighborhood and within 0.28 of a mile from the subject

property. The comparables consist of class 2-04, 1-story or "5-story" dwellings of frame, masonry or frame and masonry exterior construction ranging in size from 1,921 to 2,503 square feet of living area. The dwellings are 58 to 70 years old. The comparables have a partial or full basement, but the finished area was not disclosed by the appellant. Each comparable has 1 to 3 fireplaces, and either a 1.5-car or a 2-car garage. Four comparables each have central air conditioning. The comparables have improvement assessments ranging from \$40,000 to \$50,500 or from \$15.98 to \$22.57 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced.

The board of review submitted its "Board of Review Notes on Appeal." The appellant submitted a copy of the Cook County Board of Review final decision disclosing the total assessment for the subject property of \$76,497. The subject property has an improvement assessment of \$56,798 or \$25.01 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on three comparables located within the same assessment neighborhood, including one is with the same block, as the subject property. The comparables consist of class 2-04, 1-story dwellings of masonry or frame and masonry exterior construction ranging in size from 2,153 to 3,101 square feet of living area. The comparables are 51 or 65 years old. Each comparable has a partial or full basement with one having finished area, 1 to 3 fireplaces and a 2-car garage. Two comparables each have central air conditioning. The comparables have improvement assessments ranging from \$56,154 to \$78,175 or from \$25.21 to \$26.08 per square foot of living area. Based on this evidence, the board of review requested the assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted nine comparable properties for the Board's consideration. The Board gives less weight to the appellant's comparables #2 and #4 along with board of review's comparables #1 and #3 which differ significantly from the subject in design, dwelling size, age, and/or lack of a central air conditioning amenity, a feature of the subject.

The Board finds the best evidence of assessment equity to be the parties' remaining comparables which are relatively similar to the subject in location, design, dwelling size, age and features. These three comparables have improvement assessments ranging from \$40,000 to \$56,154 or from \$15.98 to \$26.08 per square foot of living area. The subject's improvement assessment of \$56,798 or \$25.01 per square foot of living area falls above the range established by these comparables on an overall improvement assessment basis and within the range on a per square foot basis. The subject's overall higher improvement assessment is reasonable given the

subject's somewhat larger dwelling size, newer age and/or differences in finished basement area, if any, in relation to these three best comparables. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
