

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Anna Sayles, the appellant, by attorney Andrew S. Dziuk, of Andrew Dziuk, Esq. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$7,500 **IMPR.:** \$19,500 **TOTAL:** \$27,000

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is a 69-year-old, one-story dwelling, consisting of frame and masonry construction with 1,054 square feet of living area. Features of the home include one full bathroom, one-half bathroom, a partial basement, and air conditioning. The property is a 7,500 square foot site located in Arlington Heights, Wheeling Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on five equity comparable properties. The comparable properties were located within the same neighborhood code with an unknown proximity to the subject. They range in age from 62 to 71 years; in size from 1,172 to 1,254 square feet of living area; and have improvement assessment from \$12.78 to \$15.30 per square

foot of living area. The appellant's residential appeal petition to the Appeals Board dated 9/6/2023 has "Yes" indicated for central air in Section III description of property. In Section V of the same petition, the comparable chart grid, supplied by appellant, the subject property is indicated "N" or no for air conditioning. The Section V grid form indicates "N/A" for finished basement area. The appellant requested the subject's total assessment be reduced to \$20,970.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$27,000. The subject property has an improvement assessment of \$19,500 or \$18.50 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four equity comparable properties. The suggested comparable properties are located on the same block as the subject; range in age from 68 to 69 years; in size from 1,046 to 1,080 square feet; and have improvement assessments ranging from \$19.90 to \$20.89 per square foot of living area. The board of review's evidence indicated yes for air conditioning, and "formal rec. room" for basement area. The board of review requested that the assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Clear and convincing evidence means more than a preponderance of the evidence, but it does not need to approach the degree of proof needed for a conviction of a crime. Bazyldo v. Volant, 164 Ill. 2d 207, 213 (1995).

Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparable properties to the subject property. 86 Ill.Admin.Code §1910.65(b). The Illinois Constitution requires that real estate taxes "be levied uniformly by valuation ascertained as the General Assembly shall provide by law." Ill. Const., art. IX, § 4 (1970); Walsh v. Property Tax Appeal Board, 181 Ill. 2d 228, 234 (1998). This uniformity provision of the Illinois Constitution does not require absolute equality in taxation, however, and it is sufficient if the taxing authority achieves a reasonable degree of uniformity. Peacock v. Property Tax Appeal Board, 339 Ill. App. 3d 1060, 1070 (4th Dist. 2003).

The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be appellant's comparable properties #1, #3, and #4 and the board of review comparable properties #2, #3, and #4. These comparable properties had improvement assessments that ranged from \$12.78 to \$20.55 per square foot of living area. The subject's improvement assessment of \$18.50 per square foot of living area falls within the range established by the best comparable properties in this record. After considering all the best comparable properties submitted by the parties with emphasis on those properties that are more proximate in location and with similar features relative to the subject and after further

considering adjustments to the best comparable properties for differences from the subject, and factoring in the ambiguity in the record regarding air conditioning, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
