



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Katherine Sikaras, the appellant, by attorney Andreas Mamalakis, of the Law Offices of Andreas Mamalakis in Kenosha; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$13,664
IMPR.: \$37,501
TOTAL: \$51,165

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2022 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of frame and masonry exterior construction with 2,476 square feet of living area. The dwelling is approximately 54 years old. Features of the home include a full basement with finished area,¹ central air conditioning, a fireplace, 3 full baths, and a 2-car garage. The property has an 9,760 square foot site and is located in Northbrook, Northfield Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on five equity comparables with the same assessment neighborhood code as the subject and located within .19 of a mile from the subject, two of which are located on the same street. The comparables are

class 2-78 properties improved with 2-story dwellings of frame and masonry exterior construction ranging in size from 2,542 to 2,922 square feet of living area. The dwellings are 52 to 58 years old and have partial basements. The comparables each have central air conditioning, one fireplace, 1 or 2 full baths, 1 half bath, and a 2-car garage. The comparables have improvement assessments ranging from \$30,000 to \$39,892 or from \$11.80 to \$13.75 square feet of living area. Based on this evidence the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal." The final decision submitted by the appellant disclosed the total assessment for the subject of \$51,165. The subject property has an improvement assessment of \$37,501 or \$15.15 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on three equity comparables with the same assessment neighborhood code as the subject and located on the same block and street as the subject. The comparables are class 2-78 properties improved with 2-story dwellings of frame and masonry exterior construction with either 2,104 or 2,138 square feet of living area. The homes are 52 or 53 years old and have partial basements with finished area. Each comparable has central air conditioning, one fireplace, 3 full baths, and a 2-car garage. Two comparables each have one bath and one comparable has a fireplace. The comparables have improvement assessments ranging from \$33,396 to \$35,986 or from \$15.62 to \$16.83 per square foot of living area. Based on this evidence the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight suggested comparables for the Board's consideration. The Board gives less weight to the appellant's comparables which are not reported to have finished basement area like the subject.

The Board gives most weight to the board of review comparables which have finished basement area and are most similar to the subject in location with varying degrees of similarity in dwelling size, age and features. These three comparables have improvement assessments ranging from \$33,396 to \$35,986 or from \$15.62 to \$16.83. The subject's improvement assessment of \$37,501 or \$15.15 per square foot of living area is above the range established by the comparables in the record on an overall basis and below the range on a square foot basis which is logical due to the subject's larger dwelling size. Based on this record and after considering adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not

demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
