



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Jonathan Hutchins, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Hawthorn Woods, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$17,435
IMPR.: \$93,329
TOTAL: \$110,764

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of vinyl siding exterior construction with 2,294 square feet of living area. The dwelling is approximately 28 years old. Features of the home include a full basement with finished area, central air conditioning, a fireplace and a 420 square foot garage. The property has an 8,560 square foot site and is located in Grayslake, Avon Township, Lake County.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted an appeal petition with nine equity comparables presented in the Section V grid analysis of the petition. The appellant also submitted a spreadsheet with three additional comparables that was not presented on the Board's prescribed forms as required by Section 1910.80 of the Board's procedural rules (86 Ill. Admin. Code § 1910.80). The Board issued Standing Order No. 2 that applies to all matters filed after

February 28, 2023, whereas all parties, including appellants, intervenors and boards of review are ordered to use the Board's prescribed forms in accordance with Section 1910.80 of the Board's procedural rules whether a party is filing by paper or through the e-filing portal. Any party not complying with the Board's rules will be subject to sanctions. The sanction is to give any evidence not submitted on the proper form zero weight. Therefore, pursuant to the Board's strict application of Section 1910.80, as articulated in Standing Order No. 2, the spreadsheet containing information on the additional comparable properties submitted by the appellant is given no weight.

The nine comparables presented in the Section V grid analysis are improved with two-story dwellings ranging in size from 2,294 to 2,344 square feet of living area. The homes range in age from 31 to 33 years old. Each comparable has a basement, central air conditioning, and a garage with either 420 or 440 square feet of building area. Five of the comparables also have a fireplace. The comparables have the same assessment neighborhood code as the subject and are located from 0.64 of a mile to 1.13 miles from the subject property. The comparables have improvement assessments that range from \$86,376 to \$89,164 or from \$37.65 to \$38.12 per square foot of living area. The appellant requested the subject's improvement assessment be reduced to \$86,885 or \$37.87 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$110,764. The subject property has an improvement assessment of \$93,329 or \$40.68 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables improved with two-story dwellings of vinyl siding exterior construction with each containing 2,294 square feet of living area. The homes are either 29 or 31 years old. Each comparable has a full basement with finished area, central air conditioning, a fireplace and a 420 square foot garage. The comparables have the same assessment neighborhood code as the subject and are located from 0.06 of a mile to 1.02 miles from the subject property. The comparables have improvement assessments that range from \$93,530 to \$98,145 or from \$40.77 to \$42.78 per square foot of living area. The board of review requested confirmation of the subject property's total assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains 13 equity comparables submitted by the parties to support their respective positions. The Board finds that all 13 comparable properties are representative of the subject property and are improved with dwellings that are relatively similar to the subject in location,

dwelling size, age, style, and features, although adjustments to these comparables to account for differences in some features, would be needed to make them more equivalent to the subject. The Board further finds the best evidence of assessment equity to be the board of review's comparables, which are identical in dwelling size, garage square footage, basement area, and are nearly identical in terms of amenities, including finished basement area. These comparables are located from 0.06 of a mile to 1.02 miles from the subject, have 2,294 square feet of living area and are either 29 or 31 years old. Their improvement assessments range from \$93,530 to \$98,145 or from \$40.77 to \$42.78 per square foot of living area. The subject's improvement assessment of \$93,329 or \$40.68 per square foot of living area falls slightly below the range established by the best comparables in this record. Based on this record and after considering any appropriate adjustments, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
