

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Elizabeth Wolkoff DOCKET NO.: 23-01376.001-R-1 PARCEL NO.: 16-10-316-031

The parties of record before the Property Tax Appeal Board are Elizabeth Wolkoff, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Hawthorn Woods; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$60,355 **IMPR.:** \$109,858 **TOTAL:** \$170,213

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

## **Findings of Fact**

The subject property consists of a 1-story dwelling of brick exterior construction with 1,870 square feet of living area. The dwelling was constructed in 1956, is approximately 67 years old, and has a reported effective age of 1959 or 64 years old. Features of the home include a basement with finished area, central air conditioning, a fireplace, and a 368 square foot garage. The property has a 20,315 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on five comparable sales located within 0.33 of a mile from the subject. The parcels range in size from 12,336 to 17,476 square feet of land area and are improved with 1-story homes ranging in size from 1,534 to 2,062 square feet of living area. The dwellings range in age from 65 to 70 years old. Each home has a basement, one of which has

finished area,<sup>1</sup> and central air conditioning. Three homes each have a fireplace and four homes each have a garage ranging in size from 231 to 528 square feet of building area. The comparables sold from February 2022 to June 2023 for prices ranging from \$375,000 to \$584,000 or from \$188.17 to \$311.79 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$170,213. The subject's assessment reflects a market value of \$510,690 or \$273.10 per square foot of living area, land included, when using the statutory level of assessment of 33.33%. In support of its contention of the correct assessment the board of review submitted information on two comparable sales located within 0.33 of a mile from the subject. Comparable #1 is the same sale as the appellant's comparable #4 described above. Comparable #2 has a 15,061 square foot site that is improved with a 1-story home with 1,912 square feet of living area. The dwelling is 67 years old and features a basement with finished area, central air conditioning, a fireplace, and a 520 square foot garage. The comparable sold in November 2022 for a price of \$599,900 or \$313.76 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

# **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Adm.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Adm.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of six comparable sales, with one common sale, for the Board's consideration. The Board gives less weight to the appellant's comparables #1, #2, #3, and #5, due to substantial differences from the subject in dwelling size and/or basement finish.

The Board finds the best evidence of market value to be the board of review's comparable #1/appellant's comparable #4 and the board of review's comparable #2, which sold proximate in time to the assessment date and are similar to the subject in dwelling size, age, location, site size, and features. These two most similar comparables sold for prices of \$584,000 and \$599,900 or \$310.31 and \$313.76 per square foot of living area, including land, respectively. The subject's assessment reflects a market value of \$510,690 or \$273.10 per square foot of living area, including land, which falls below the two best comparable sales in this record. Based on this evidence and after considering appropriate adjustments to the best comparables for differences from the subject, the Board finds a reduction in the subject's assessment is not justified.

<sup>&</sup>lt;sup>2</sup> Section 1910.50(c)(1) of the Board's procedural rules provides that in all counties other than Cook, the three-year county wide assessment level as certified by the Department of Revenue will be considered. 86 Ill. Adm. Code § 1910.50(c)(1). As of the development of this Final Administrative Decision, the Department of Revenue has not published figures for tax year 2023.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
