



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Kim and Eric Lundquist

The parties of record before the Property Tax Appeal Board are Kim and Eric Lundquist, the appellants, by attorney Timothy C. Jacobs, of Kovitz Shifrin Nesbit in Mundelein; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$23,963
IMPR.: \$112,726
TOTAL: \$136,689

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of vinyl siding exterior construction with 2,680 square feet of living area. The dwelling was constructed in 1991 and is approximately 32 years old. Features of the home include a basement, central air conditioning, a fireplace and a 400 square foot garage. The property has a 15,841 square foot site and is located in Mundelein, Fremont Township, Lake County.

The appellants contend overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on five comparable sales located within .27 of a mile to 1.62 miles from the subject. The comparables have sites ranging in size from 7,819 to 16,140 square feet of land area and are improved with 2-story dwellings of vinyl siding exterior construction ranging in size from 2,302 to 2,703 square feet of living area. The dwellings are 31 to 33 years old and have basements. Each home has central air conditioning, one fireplace, and a garage

ranging in size from 400 to 484 square feet of building area. The comparables sold in May 2021 to April 2023 for prices ranging from \$320,000 to \$380,750 or from \$117.05 to \$137.45 per square foot of living area, including land. Based on this evidence, the appellants requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$136,689. The subject's assessment reflects a market value of \$410,108 or \$153.03 per square foot of living area, land included, when using the statutory level of assessment.¹

In support of its contention of the correct assessment the board of review submitted information on three comparable sales located from .25 of a mile to 1.21 miles from the subject. The comparables have sites ranging in size from 7,775 to 12,179 square feet of land area and are improved with 2-story dwellings of vinyl siding exterior construction ranging in size from 2,302 to 2,703 square feet of living area. The dwellings are 31 to 33 years old and have basements with one having finished area. Each home has central air conditioning, one fireplace, and a garage with 400 to 484 square feet of building area. The comparables sold in August 2022 or August 2023 for prices ranging from \$378,500 to \$490,000 or from \$160.41 to \$181.28 per square foot of living area, including land. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight comparables sales for the Board's consideration. The Board gives less weight to appellants' comparable #5 which sold in 2021, less proximate in time to the January 1, 2023 assessment date than the remaining comparable sales in the record.

The Board finds the best evidence of the subject's market value to be the remaining comparables in the record which sold more proximate in time to the assessment date at issue and are relatively similar in age, dwelling size, and most features. The comparables sold from January 2022 to August 2023 for prices ranging from \$320,000 to \$490,000 or from \$119.40 to \$181.28 per square foot of living area, including land. The subject's assessment reflects a market value of \$410,108 or \$153.03 per square foot of living area, including land, which falls within the range established by the best comparable sales in this record. After considering adjustments to the best comparable sales for differences when compared to the subject, the Board finds the subject's

Prior to the drafting of this decision, the Department of Revenue has yet to publish figures for tax year 2023.

estimated market value as reflected by its assessment is supported and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
