



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: The Bryant Apartments of Oak Park.

The parties of record before the Property Tax Appeal Board are The Bryant Apartments of Oak Park., the appellant, by attorney Thomas E. Sweeney of Siegel Jennings Co., LPA, in Chicago; the Cook County Board of Review; Oak Park & River Forest HSD #200, intervenor, by attorney Ares G. Dalianis of Franczek P.C., in Chicago; and Oak Park School District #97, intervenor, by attorney Scott L. Ginsburg of Robbins Schwartz, in Chicago.

Prior to the hearing, the appellant and Oak Park School District #97 reached an agreement as to the correct assessment of the subject property. The Cook County Board of Review and Oak Park & River Forest HSD #200 were notified of this suggested agreement and given thirty (30) days to respond if the proposed assessment agreement was not acceptable. The Cook County Board of Review did not respond to the Property Tax Appeal Board by the established deadline. Oak Park & River Forest HSD #200 responded to the Property Tax Appeal Board after the established deadline but ultimately accepted the proposed assessment.

After reviewing the record and considering the evidence submitted, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this **Cook** County appeal. The Property Tax Appeal Board further finds that the agreement of the parties is proper, and the correct assessed valuation of the property is:

LAND: \$ 58,206
IMPR.: \$841,794
TOTAL: \$900,000

Subject only to the State multiplier as applicable.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
