



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Mahmoud Aldabe, the appellant(s), by attorney Andreas Mamalakis, of the Law Offices of Andreas Mamalakis in Kenosha; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,697
IMPR.: \$36,306
TOTAL: \$42,003

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a twenty-one-year-old, two-story dwelling of frame and masonry construction with 2,226 square feet of living area. Features of the home include a full basement, central air conditioning, a fireplace and a two-car garage. The property has two full bathrooms and a half bath. The property has a 9,116 square foot site and is in Orland Park, Orland Township, Cook County. The subject is classified as class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant asserts assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on five suggested equity comparables. The suggested comparable properties range in size from 2,331 to 2,566 square feet of living area. Each suggested comparable had one fireplace, a full basement, and air conditioning. Three of the suggested properties had two full bathrooms and a half bathroom, one property had one full

bathroom and two half bathrooms, and one property had two full bathrooms. Four of the comparables had a two-car garage and one comparable had a three-car garage. The appellant reported that the suggested comparables were located between 0.43 and .68 miles from the subject property and ranged in age from 33 to 37 years old. The comparables have improvement assessments ranging from \$8.37 to \$12.16 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's assessment to \$30,741.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject as \$42,003. The subject property has an improvement assessment of \$36,306 or \$16.31 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on three suggested equity comparables. The suggested comparable properties ranged in size from 2,086 to 2,228 square feet of living area. Each comparable suggestion had one fireplace, a full basement, and air conditioning. Each of the suggested properties had two full bathrooms and one-half bathroom. The comparables had varying sized garages ranging from two-car to three-car. The board of review reported that the suggested comparables were located on the same block or within a quarter mile of the subject property and were each 22 years old. The comparables have improvement assessments ranging from \$16.37 to \$18.57 per square foot of living area. Based on this evidence, the board of review requested that the assessment be confirmed.

Conclusion of Law

The taxpayer asserts assessment inequity as the basis of the appeal. The Illinois Constitution requires that real estate taxes "be levied uniformly by valuation ascertained as the General Assembly shall provide by law." Ill. Const., art. IX, § 4 (1970); Walsh v. Property Tax Appeal Board, 181 Ill. 2d 228, 234 (1998). This uniformity provision of the Illinois Constitution does not require absolute equality in taxation, however, and it is sufficient if the taxing authority achieves a reasonable degree of uniformity. Peacock v. Property Tax Appeal Board, 339 Ill. App. 3d 1060, 1070 (4th Dist. 2003).

When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill. Admin. Code §1910.63(e); Walsh, 181 Ill. 2d at 234 (1998). Clear and convincing evidence means more than a preponderance of the evidence, but it does not need to approach the degree of proof needed for a conviction of a crime. Bazyldo v. Volant, 164 Ill. 2d 207, 213 (1995). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill. Admin. Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds that the best evidence of assessment equity is the board of review's suggested comparables one through three, and the appellant's comparable one. Like the subject property, each of these comparables has a two-story, single-family dwelling of frame and masonry construction, a full or partial basement, a fireplace and were located in the same neighborhood. These comparables had the most similar sized living areas to the subject property compared to the other comparables. In comparison, the appellant's remaining comparables were larger in

living space square feet than the other comparables. Additionally, the appellant's remaining comparables were farther from the subject property than the board of review's comparables. The Board finds that these comparables are afforded less weight based on their difference in size, proximity, and additional differences in property characteristics.

These comparables have improvement assessments that range from \$8.37 to \$18.57 per square foot of living area. The subject's improvement assessment of \$16.31 per square foot of living area is within the range established by the best comparables in this record. The Board therefore finds that the appellant did not demonstrate with clear and convincing evidence that the subject was inequitably assessed, and a reduction in the subject's assessment on this basis is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
